Article 01 – Restrictions on the PluralBot

1. The bot Pluralkit or one that provides similar functionality, referred to as PluralBot shall be added. Use of the bot shall be available to any citizen upon confirmation of the Discord Supervisor or another individual with access to the bot.
 - 1.1. In case of an account abusing their privileges, such as harassment, belittlement, or discrimination of plurality or systems, or breaking the laws of SimDemocracy, their permissions to use the PluralBot may be removed.
2. The PluralBot must have access to all publicly accessible channels.
3. All plural people or systems must connect the account and the members shown through the PluralBot to show where the members come from. For example, if there was an account named Kilian, with a tulpa named Gary, Gary's screen name could be "Gary (Kilian's Tulpa)".

Article 02 – Rights of Plural People and Systems

1. All people who identify as plural or have systems are entitled to protection from harassment and discrimination for their identity.
2. People who identify as plural and systems must vote as one, no system may vote more than once, regardless of how many individuals exist within the system.
3. All actions made by a plural individual or a system, regardless of who, will be held responsible to the account owner. The actions of one member of a system will be reflected by all members legally.
4. Alternative accounts (alts) may join the discord server and post and follow the subreddit; however, only one account may become a citizen. Actions committed by any alts are liable for all of the alts.

Article 03 – Definitions

1. A system is defined as the state of having more than one person/consciousness sharing a body. Consciousnesses part of a system are called system members, system mates, or

alters. Plurality is defined as an umbrella term encompassing all phenomena in which multiple consciousness cohabit a single brain and body. Singlet is defined as when one consciousness is in one brain. Essentially, someone who is not plural. Proxying is defined as when a fronter controlling the body relays the words and actions of a member who is not controlling the body to the outerworld.

2. A tulpa is defined as an autonomous consciousness coinhabiting a brain with their creator, often with a form of their creator's initial choice and design. They are entirely sentient and in control of their opinions, feelings, form and movement. A daemon is defined as a personified version of the second half of someone's mental dialogue, usually mentally represented in an animal form. A median is defined as a system with members who are not inherently independent from each other, and are often dependent on a single individual and unable to exist without that central person. A fictive is defined as a system member who arrives in the system with the form, and personality of a fictional character, often characters created by people outside of the system.
3. The front is defined as the place from which system members experience the world-at-large, or outerworld. Fronting is the action of experiencing it. The one fronting is the fronter or frontrunner. Switching is defined as the changing of fronters. Merging is defined as multiple (two or more) system members merging together to form one member. Innerworld, Wonderland, headspace, mindscape, or inside is defined as a world or location that is accessible mentally by a system.

§2. Hate speech is to be any upsetting, demeaning, or humiliating speech about someone's race, religion, disability, gender, sex, sexuality, plurality, or national origin.
