### **Background:**

#### Scope of Work:

The Community Planning Expert will be responsible for providing technical and strategic support in the following areas:

- Developing and facilitating training programs for community stakeholders.
- Guiding the formulation and implementation of community development and participatory budgeting plans.
- Ensuring the integration of sustainability and inclusiveness in all planning processes.
- The expert is estimated to work 25 days for delivering the tasks. The remuneration will be calculated based on the days that expert work to deliver the tasks.

#### **Main Tasks:**

- Capacity building of social service providers, CSOs and LPAs in project writing.
- Develop a capacity building programme for social service providers, CSOs and LPAs on alternative fundraising instruments.
- Supporting the development of partnerships to address community challenges in a participatory way.
- Contribution to the organization of 3 round tables and 3 study visits with ATAS representatives.

- At least 5 years of professional experience in the social services sector.
- Fluency in Romanian and Russian are required.

### **Evaluation criteria:**

In order to select the expert offering the best value for money, proposals will be evaluated using the "least price and quality" method. The weighted ration between technical and financial criteria are set as following:

- Technical Evaluation weight 60%
- Financial Offer weight 40%

The quality criteria will be assessed using a weighted scoring system as outlined below:

Minimum Technical Threshold: The minimum competency level for the technical evaluation is for Applicants to reach at least 70% out of maximum possible 60 points on the technical evaluation. Only offers with technical score of at least 42 points qualify for the financial evaluation.
