

Artificial Intelligence: General Philosophy Statement

[POD Perspectives](#) papers are contributions intended to influence the complex web of human and digital interactions that contribute to the institutional ecosystem in higher education. We value your unique voices as POD members and participants in this ecosystem, and we invite you to author what you consider the best evidence-based scholarly contribution for an audience that includes those with the power to make far-reaching decisions. We encourage our authors to center your own voices, and those of your colleagues, and to make sure that generative artificial intelligence (A.I.) tools support, but do not supplant, your contribution.

To this effect, we ask that all authors use the following tool to disclose whether and how they used generative A.I. tools in preparing their work.

Artificial Intelligence Disclosure Instrument

Please select from the following list any of the items that are true for your manuscript—you may make multiple selections on this form. Each item includes a description of use and a note explaining the ramifications of the selection.

- A.I. tools were not used** in the process of preparing the manuscript.
NOTE: This is the “traditional” option and does not influence how your document is presented to the editors or readers.
- A.I. tools were used during prewriting**, in processes such as brainstorming, topic generation, identifying research questions, exploration of existing literature on a topic, outlining, and other possible uses at this early stage of writing.
NOTE: At this time, this level of use requires disclosure here, for the purposes of our review process, but does not require disclosure elsewhere in the manuscript.
- A.I. tools were used during composing** some portions of the manuscript, which were then reviewed and edited or organized by a human author.
NOTE: This selection will add this disclosure note to the published manuscript, for the reference of our readers, and for copyright purposes. Please note that in the U.S.A., copyright protection does not include material composed by artificial intelligence. The legal situation here is evolving rapidly, and it is not yet clear how documents that include a mixture of A.I. generated and human written text may or may not be protected, but as a service to our readers and future editors of this publication, we feel it prudent to “flag” articles that include A.I. generated material.
- A.I. tools were used during copy-editing or proofreading**, including polishing vocabulary, wordsmithing, tailoring the writing style to the audience, and other possible uses at this late stage of the writing process.
NOTE: This selection will add a footnote to the manuscript disclosing the use of generative A.I. for this purpose. Please do not select this option if you simply used spell-check or thesaurus tools that do not use generative A.I. for composition. As in each

of these levels of disclosure, if you are unsure about the definitions used here, or how your workflow fits the categories, you are welcome to contact the editors.

GENERAL NOTE ON RESEARCH METHODS: The use of A.I. tools as part of the research methodology, including literature search procedures for a systematic review or related genre, should be described in detail within the manuscript text, in the relevant methodological and results section(s), and need not influence the disclosure you make here. That is, if you used A.I. tools as part of your research methodology, and described that use in your paper, you may choose “**were not used.**” If you are uncertain about how best to report what you did, you are welcome to contact the editors.

GENERAL NOTE ON GRAPHICAL ELEMENTS: The legal and ethical situation of graphical generative A.I. tools is even more complex than that of text-generating A.I. tools. For now, if you used generative A.I. tools to create graphical elements, you will need to make a judgment call on which category to select. If you used generative A.I. to *create* graphical elements from the ground up, you should select “**used during composing,**” but if you only used A.I. to polish or optimize graphical elements, you may select “**used during copy-editing or proofreading.**” If you are unsure how to handle this kind of disclosure, you are welcome to contact the editors.

Thank you for your submission and the understanding that these guidelines may shift or change as the A.I. landscape evolves over time. We look forward to reading your work.
