1. Rev. Scott's Report.

Rev. Scott's report approved

- Chris—yes on the good work done, as shown in the photos. Finance Cmte met on Thursday—emergency work to be approved.
- Costs of repairing roof—a small fund drive is a possibility—roof hasn't failed yet, but definitely needs to be fixed.
- We need to bring the repair budget back up—used to be 30K—we have a 115-yo facility.
- Lauren—a big thank you! Good work by Rev. Scott. Question on roof, seconding Chris.
- Rev. Scott—progress has been possible because people in leadership have recognized needs. Getting an estimate on the roof. Probably will be about \$170-200K.

- Deb—members of the council—we are exploring the role of the council—thank you for supporting our recent retreat, part I! Rev. Emily from Beacon was very good.
- We have reorganized our covenant and are creating new organizing questions.
- Ministerial evaluations every other year, so we can focus on ministries in the alternate years—we may need to revise our charge.
- Need to redo a bylaw provision that does not mention ministers as members of CoM and also language that incorrectly implies review power over the Bd.
- Michael—sounds good.

4. Treasurers Report

Chris

7:41-7:56

- 25% into the year. Our expenses are fine, our income is a bit low. Our long-term tenants are all paying again. Endowment earnings are good. Fundraising is an issue. Higher employee costs, as planned—RE, reopening. We're in a 23K surplus, good but down from 52K last year.
- Francesca—low Social Justice spending? Scott—probably just related to lack of big events so far.
- Chris—no MESH spend so far. We could focus on congregational giving, given the good MESH \$ situation.
- Ramona—September was disappointing—a 2.2% loss--but this was considerably better than the larger losses of the major U.S. stock indices. We have a balanced portfolio—international portion did better than the indices, as did our Vanguard funds and our bonds. Good performance in October—making up the September loss—volatile market. Lauren—fossil fuels? Chris—ESG funds, plus others that do not have tobacco or fossil fuels.
- Peter—Include the building as an asset? Chris—Usually not done in non-profit—value of building is around \$3.5 million—but it's not an asset that we're going to sell, and we can't get a

- standard home equity loan against it.
- \$2450 in Shop-Rite Cards—the U gets 5%--any of you who shop there, we'd like to liquidate the cards.

#### NLDC Leadership Support Council

Rev. Anya 8:06-8:24

- Under new charge, NLDC works on leadership development. Idea is to have a council of trusted leaders. Planning regular gatherings. Identifying leaders is sensitive—plan shared with CoM. Reactions?
- Michael—great plan. Lauren—I'll be devil's advocate—I'm skittish about creating another group. Too many mtgs? Chris—let's ask for people in order of priority—pledge, auction, etc. are important—need for hands-on roles to be filled before an ancillary cmte is formed. Sarah—agrees with that point. Nick—I've been recruited—let's see how it works. Rev. Scott—this relates to the bylaws and the size of the Bd. Rev. Anya—idea is to mentor and support leaders, not to recruit them. Giancarlo—bringing new people into the fold is impt. Rev. Anya—I can craft a response for NLDC based on Bd comments—could use your input, Lauren.

New Auction Team Michael/Chris 8:25-8:33

- Michael--We need to get a team together—how many people? Rev. Scott—Bd liaison.
   Nick—5-6 key people including a chair or co-chairs, 15-20 volunteers, at least 1-2 tech people, publicity/communications. A new structure is needed for the new auction.
- Francesca—some questions re free raffle tickets—main question is how we do this in the age of Covid? Chris—positive changes re Covid may happen by Spring, when the auction will be this year. Michael—volunteers? Peter—On reopening. Chris—Yes. Nick—Yes, if not to lead. Tech person who knows software wd be impt.
