INTRODUCTIONS FOR FORMAL HISTORICAL ESSAYS

In a formal essay for history, you need to set the context for your reader – in other words, you need to help the reader locate him/herself in time and place, so that s/he s/he understands what you're going to discuss in depth later on in your essay. If you write a strong enough introduction, someone with NO background knowledge about your topic should be able to read and understand your essay.

First sentence – give time period and location. Make a general statement about what was going on at the time. Use the prompt (if you have one) to help you with this!

Second/third sentence/s – Give any background information the reader will need to keep in mind in order to understand the topic. This also can reflect the prompt.

Connecting sentence – start leading into your thesis statement/s.

Thesis: This should already have been approved. Write it bere-

Thesis – make sure it is DIRECTLY RELATED to your prompt!

Example:

Introduction for a World History essay on the question, What were the major developments in art during the Renaissance?:

The 1500s was an era of enormous growth and change in Italy. The Renaissance period, which means "rebirth," saw a renewed interest in ideas from classical Greek, Roman, and Arab societies. Knowledge that had been lost in the "Dark Ages" was rediscovered and new forms of art and architecture were created.

Powerful Italian families supported a

number of famous artists whose work is still admired today. Artists like Michelangelo Buonarotti and Leonardo Da Vinci combined new techniques involving perspective and use of light with classical elements to create masterpieces of artwork.
