Acronyms should not be used in the summary. The summary has a maximum of 150 words.

Descriptors: From Three to Five; in the Submission Language; According to DeCS/MeSH; Separated by Semicolon; First Capital Letter in Each Word.

The main document is all in Microsoft Word® file, doc or docx type, A4 size paper configuration, single line spacing, 3pt spacing after the paragraph, 0.75 indentation, with top, bottom, left and right margins of 2 cm . Use Calibri font size 10, black.

Do not start a new page with each subheading; Separate them using a blank line. In all categories of original work, the text must have an easily recognizable organization, signaled by a system of titles and subtitles that reflect this organization.

The introduction section is concise, announces the problem studied and its importance, highlights gaps in knowledge, presents the research question and the objectives and objectives are identical to those presented in the summary, are allocated in the last paragraph of the introduction, and are started by a verb in the infinitive (action).

Theoretical reference

When applicable, it is found in the Introduction subsection. Presents the assumptions/concepts of the theory in a concatenated way. Contextualizes the theory's view of the research problem.

METHOD

The method specifies and justifies the type of study and presents the related methodological framework adopted. Should the text make it clear that the authors followed the Equator Network Health Research Quality and Transparency Recommendations and in accordance with the study design? Recommendations/Guidelines Equator Network (http://www.equator-network.org), as well as that the authors followed SAGER/DEIA recommendations/guidelines.

There is a description of the population/participants, the geographic location and characterization of the research site, the type of sample and eligibility/selection criteria, the sample calculation, the data source and data collection period.

If the data collection period of the submitted article is longer than five years from the date of submission of the manuscript, a justification must be presented with a theoretical-methodological basis.

The study variables/categories, the type of data analysis and methodological framework used, the coding used to designate participants in the case of studies with a qualitative approach are presented.

In case of prior publication (preprint), it is cited in the text, with presentation of the DOI.



Ethical aspects include, in the last paragraph of the section, information regarding the approval of the study by the Research Ethics Committee and the obtaining of informed consent, highlighting compliance with the required ethical standards, but without presenting the name of the Committee, the protocol number , CAAE or name of the institution involved with the approval, if there is no specific authorization for this disclosure. There is no need to cite the Resolutions of the National Health Council.

In the case of using Artificial Intelligence Tools, there is a mention of the tool and the purpose of its use.

RESULTS

This section may be presented in conjunction with the Discussion section. If the database is available in a repository, it must be described at the beginning of this section, with availability of the access link to the study database.

They are described logically and respond to the objectives, using past tense, including interpretations, comments or comparisons.

The total number of tables/charts/figures should not exceed three illustrations. Tables must be submitted, in an editable format in Word® itself, formatted and incorporated into the main manuscript document. Present each table incorporated into the main document, with a sequentially numbered title, composed in MS-Word. The length of the table must not exceed 55 lines, including title, and width limited to 8cm, 12cm or 16cm, typed in Calibri font, size 10 and single line spacing, without any form of tabs or paragraph indents. The table must be laid out in Portrait orientation, Landscape orientation is not accepted. All illustrations that do not fit the definition of table are considered as figures; therefore, tables, graphs, drawings, photos, etc.

Full transcriptions of quotations should be avoided. In the case of use, should it be restricted to three lines, delimited by quotation marks and numbered according to the order of citation in the text.

Should the quotation of excerpts from interviewees' statements be presented with a 2.5cm indentation from the left margin, in italics, without quotation marks and with the fictitious identification of the deponent? (Ex: E1, E2, ...). Long statements must be reduced by using suppressions with the use of ellipses in square brackets [...], in any part of the sentence (beginning, middle, end). After the statement, is there the identification letter and number of the corresponding interviewee, in parentheses and in italics? E.g.: E1, E2, E3...

Discussion

It must be in-depth and restricted to the results obtained and achieved, emphasizing the new and important aspects of the study.

Discuss agreements and divergences with other national and international research with up-to-date scientific evidence.

Study limitations

Study limitations and implications for the advancement of scientific knowledge in health and nursing should be presented at the end of this section.

CONCLUSION/FINAL CONSIDERATIONS

It must be synthetic and clearly indicate the achievement of the desired objectives. There should be no citation of references.

REFERENCES

In black font, Calibri 10, aligned to the left and without paragraph indentation.

The body of references must be composed of at least 75% of updated articles, with up to five years of publication and national and international coverage, numbered sequentially, with a period after the number, followed by the credits and without space between the period and the credits. References from publications that do not adequately comply with a reliable editorial flow for peer review should not be used.

In accordance with the Vancouver style, the authors' index numbers are superscripted and without parentheses in the body of the text, before the punctuations (Ex.: 8.), and consecutive citations from two authors have the corresponding numbers and separated by comma (Ex.: 4,5) and consecutive ones from more than two authors have

the corresponding numbers and separated by a hyphen (Ex.: 4-7). Non-consecutive citations from two or more authors have corresponding numbers, in ascending order and separated by commas (Ex.: Studies4,6,8,10). Citation numbers must not contain automatic markers.

Whenever possible, references must be presented in electronic format, with titles in English and with the link referring to the DOI (Document Object Identifier) number. If the journal does not provide the DOI, the electronic address of the accessed environment was presented. The link must be presented in black, without underlining. The date of access to the link must be shown.
