The safety of students and staff in all Cherokee County Schools is paramount to success.

Every Student, Every Day will be expected to follow the Code of Conduct to ensure that all students have an equal chance to succeed.

General Notes:

If a student refuses an In-School-Suspension assignment, all subsequent consequences that would have resulted In-School-Suspension may result in Out-of-School Suspension.

However, if a parent refuses an In-School-Suspension assignment, all consequences that would have resulted In-School-Suspension will be Out-of-School Suspension for the remainder of the year.

If a student, for any reason, accumulates 5 days of OSS, they will be placed on a School Discipline Contract. The parents/guardians, school administration, student, and any appropriate stakeholders will meet in person to discuss the problem behavior/s and create a plan to address correction and consequences. All parties will sign the contract. Building Administration may choose to place a student on a School Discipline Contract for other reasons. Again, all parties will sign the contract.

Students returning from an expulsion, alternative setting, or extended suspension, will be placed on a Transition Contract. The parents/guardians, school administration, student, and any appropriate stakeholders will meet in person to discuss the previous problem behavior/s, causes for expulsion or alternative placement, and create a plan to address correction and consequences. All parties will sign the contract.

Cherokee County Elementary School Code of Conduct

Updated July 2025

Though not specifically mentioned in the list of behaviors, students may be suspended out of school for extended periods of time or recommended for expulsion for 1st time offenses or any act which is detrimental to the good order, best interest, and physical safety of the school. Students may be punished according to the nature and severity of the offense at the discretion of administration. Additional consequences will apply when students are uncooperative. All final disciplinary actions are left to the discretion of administration.

Level 1 Offenses and Consequences

Level 1 offenses will be dealt with by the teacher until they reach a chronic level (a minimum of 4 offenses), then violations can be considered Level 2.

All consequences will be age and/or developmentally appropriate.

Robbery (730)	Robbery is defined as the taking or attempting to take anything of value under confrontational circumstances from the control, custody, or care of another person by force or threat of force or violence and/or by putting the victim in fear of immediate harm. Because some type of assault is an element of the crime of robbery, an assault should not be reported as a separate crime if it is performed in furtherance of the robbery. If an injury occurring during a robbery results in death, the crime should be listed as a homicide. A report will be made to law enforcement authorities.
Forced Sex Offense (610)	A Forcible Sex offense is any sexual act directed against another person, forcibly and/or against that person's will, or not forcibly or against the person's will where the victim is incapable of giving consent (due to any reason including age, mental or physical capacity, etc.). A report will be made to law enforcement authorities.
Non-Forced Sex Offense (690)	Acts of sexual nature are prohibited on school property, or at school sponsored activities or trips; therefore, participation in sex in school or on school property/school trips is strictly prohibited. This includes transportation.

Vehicle Theft (770)	Taking a motorized vehicle that one does not own with the intent to deprive the owner of the property. A report will be made to law enforcement authorities.
Major Disruption (020)	Student arrested for any violent incident in the community. (Per the South Carolina Safe Schools Act Section 59-63-110) Ex. A report may be made to law enforcement. Any blade 2.5 in. or longer will be reported to law enforcement. A report will be made to law enforcement authorities.

The CCSD Code of Conduct applies to every student that is transported on a CCSD School or Activity Bus. Offenses/Incidents occurring on a School or Activity Bus could carry additional consequences. Most Level 1, 2, or 3 offenses from the Code of Conduct will parallel the same Level for bus offenses (occur at the same time). However, School Bus consequences could be applied in addition to the school level discipline.

School Bus Offenses

This is general guidance for school bus related discipline. Some offenses may set outside of the list below. Administration is responsible for ensuring a safe experience for all students using buses as transportation. Therefore, administrators may increase consequences for some offenses.
