Today we are mobilizing against agricultural pollution- a problem that pervades watersheds throughout the state and disproportionately impacts Indigenous communities and communities of color.

Write a letter to the editor of a newspaper/media outlet, or write to a regional water board, urging them to make controlling agricultural pollution and pesticides a top priority.

### **Key Points:**

- Industrial agricultural industries are destroying the state's sources of drinking water and face little regulation. This needs to change.
- More than 1 million people in California do not have access to clean water, and the majority of these people are Black, Indigenous, and People of Color. This is environmental injustice and environmental racism.
- We cannot solve the state's drinking water crisis unless the State Water Boards regulate agriculture and pesticide pollution and the Governor commits to standing up to big ag.
- The American Bar recognizes that agriculture is THE MAIN source of water pollution in CA.
- The Regional Water Quality Control Boards are responsible for local water quality control plans and standards. However, regulation is patchy and there is no state-wide approach for monitoring or enforcing penalties for agricultural pollution.
