#### Racer of the Year Rules: approved 14-0

- A) Most runners will be placed in an appropriate division at the annual meeting.
- B) Runners joining after 7/1 will be placed in the A division.
- C) Runners joining between 1/1 & 6/30 or not placed at the annual club meeting will be placed in a division by the club president.
- D) Club runners who run a 10K equivalent time of 1:00 or better than the fastest time range for their division will be moved to a higher division.
- E) There will be 6 divisions for 2025 A (sub 39:00), B (39:00/43:59), C (44:00/47:59), D (48:00/51:59), E (52:00/63:59), F (64:00+)
- F) Members may elect to move up to a higher division.
- G) Runners will include in their final scores their best 8 races.
- H) Designated grand prix races will count as double-point races for those who can score by having a USATF card.
- I) Runners must compete in at least 6 separate races in order to receive an award.
- J) Grand Prix races held on the weekend of a Racer of Year race will become the Racer of Year race for that weekend.
- K) All who compete in at least 6 Racer races will receive a Gold, Silver, or Bronze award. The president of club will determine the allocation of awards for each division at the end of the year.

- L) A club runner cannot score for a race unless he/she is an official entrant in the race.
- M) Club members cannot win more than one plaque in a year with Racer taking priority.
- N) Ties for 1st place will be broken by comparing head-to-head W-L records in designated Grand Prix races.
- O) Whenever best yearly half marathon and/or marathon time is part of the contest and we have a designated half marathon or marathon grand prix race, the scorer will score whichever race gives the runner the greater benefit.
- P) Runners should report their half-marathon or marathon times to Gary **within 7 days** of the race in order to count in the Racer of the Year contest.
- Q) Racer of Year rules may only be changed at the annual meeting.
- R) We will determine the designated races for this contest at the annual meeting and/or during the year.
- S)On the day we are doing a 5k, 3k, 1 mile, 1500, or 800, runners can use a time from any track. It does not have to be at WVC. The runner should report their time to **Gary the same day they run in order for the time to count in the Racer of the Year contest.**
