Guest pass behavioral expectations

All students attending Prom are expected to know that appropriate behavior is required and all school rules are enforced at any activity sponsored or supported by Claremore High School. All students and parents should be aware of the following specifics regarding school activities.

- 1. Each student must have a photo ID card.
- 2. Any student found to be: in possession of, using, or under the influence of any controlled substance, alcoholic beverage, or intoxicant of any kind will be suspended under school policy, and <u>authorities will be notified.</u>
- 3. Any vehicle, including limousines/party buses, may be searched.
- 4. Any student removed from the dance as a result of misbehavior before, during, or immediately after the dance may be excluded from any other CHS related activities for the remainder of the school year.
- 5. All guests must have an email stating their guest has been approved. All CHS students sponsoring a guest are responsible for the behavior of the guest.
- 6. Any CHS student whose behavior adversely affects the experience of another participant i.e. heckling, shouting, use of racial or other inappropriate epithets and slurs, etc.) or who damages property may be suspended and/ or excluded from any other CHS activities.
- 7. Attire must be appropriate for formal events. Students who are not appropriately dressed may be turned away at the door. Dancing must be appropriate. Lewd and lascivious dancing such as "freaking" or "dirty dancing" may result in a student being asked to leave the event.

Claremore High School encourages families to discuss these rules with their students.
