**MEMORANDUM OF UNDERSTANDING**

In order to promote co-operation between **Balaji Institute of Technology & Science**, Laknepally, Narsampet, Warangal-506331, Telangana, India and **Peoples' Governance Forum**, Pragathi Enclave Colony, Miyapur, Serilingampally, Rangareddy, Telangana, India, the two organizations agree as follows:-

The two organizations will encourage direct contact and co-operation between their faculty and administrative staff, departments and research Institutions.

Within fields that are mutually acceptable, the following general forms of co-operation will be pursued:-

Visits by an exchange of faculty members and research scholars.

Exchange of information including, but not limited to, research publications of faculty members.

Internship, Project guidance, Awards, Memberships, Fellowships to students and faculty.

Joint research activities and joint supervision of research work.

Joint conferences or symposia and like events on subject of mutual interest joint projects and supervision.

Any other form of coupling and cohesion services of academic, R&D support and integration.

This memorandum is not intended to create binding or legal obligations on either party. Both Parties must agree upon the specific terms of any inter-institution initiative relative to this agreement in written or electronic record correspondence at least three months prior to the initiation of a particular program or activity in order for the said initiative to proceed. Intellectual properties generated under this MoU shall be governed by the IPR policies of respective institutions.

Both parties understand that all financial arrangements will have to be negotiated and will depend on the availability of funds.

If the Memorandum remains dormant for FIVE consecutive years it will be deemed to have lapsed. Where the Memorandum continues to be active, the two institutions agree to review it after five years from the date hereof. It may be terminated at any time by mutual consent or by six (6) months' notice in writing by either party.

Should ongoing collaborative activities be affected by termination, the parties undertake to resolve any issue amicably by mutual agreement.

**PGF Vision:** To build a Knowledge Society based on a think tank of ICT Professionals and others for nation building by development of national virtues among the (Net) citizens.

**PGF Mission:** To transform an ill-informed society into a well-informed society (for e.g. by RTI Act method, for e.g. by serving as a Cyber policing Intelligence R&D Organization), to realise a knowledge society for the development of national virtues, to educate the people to contribute for the national good by positive participation in attending to national duties and services.
