A home was built in Cruce de Esperanza.

Father Christian R. Baret and mother Glenys C. Ortega and 4 children live in new home. 2 of the 4 children have chronic illness. The teenage son has a debilitating lung condition and the young daughter has an endocrinological disorder. They are in a continuing cycle of struggling with poverty due to the fact that much of the money the family is spent on doctor visits, treatments, and earns medications. The father tinkers with car repairs for a living. The project was under the supervision of WOPA member Jose Villalona. Mr. Lolo was the lead engineer. The project was finished at record rate of speed. The family completed all tasks assigned to them including securing volunteers and signing statement that they would occupy the house and not sell it. Most materials purchased from small businesses therefore helping the local economy.

BUDGET approved was \$6,000

Actual costs: \$8,517 (exchange rate of 51 to accommodate remittances charges).

Materials: 389,567 pesos / \$7638.57

Labor: 44,800 / \$878.43

Total \$6,000 sent from WOPA funds

President Eddie Tobal donated \$2517.

The family is extremely grateful and cried in video. This is the biggest home WOPA has built. US WOPA members traveling to DR next year plan to visit the family.
