Point 7.3 from 24/04/2022 meeting

PLU delaying reimbursement causing students to be in financial difficulty because of inaction

### Chair (BD):

"LSF funding, applying for expenses claims from the PLU - it takes a very long time to fill out the form and then actually getting reimbursed. I would like to see PLU making improvements about this"

## OL:

"From a placement in Jan-march, I put the claim in and they claimed I didn't file the correct receipts, after enquiring as to what is going on, it has been 2 months and there has been no response from the PLU and this is recurring for a number of students on placement and a lot of students are facing financial issues because of the large delay in reimbursement. The guidance has a lot of conflicting information

BD: "I still have a payment outstanding from November to the sum of £900 and had to use food banks and apply for exceptional circumstances because of this delay"

DB: "That is shocking to hear and I'll go straight to the top with this issue and not mess about. Will be in contact with Ben and Olivera regarding this."

4 Better utilisation of the Ridan composter - Max Clinch

"The SU has a composter at the Canterbury campus designed for the fresh food waste from the food hall kitchens but is not utilised enough by them due to several factors.
