because she didn't look or sound sick.

And if I got sick, then I got over it very quickly

791

and I didn't have symptoms either.

I didn't get over it all the way.

My body kept fighting and fighting

794

and I had to do a ton of IV medicine all day and night,

3 MRIs, a lumbar puncture, and more blood tests

Eventually my eye sight came back after about a month now,

but I still love to get an MRI and eye tests

Kids can be hospitalized after being exposed

812
