- 1. One source with one to five writers, followed by the year and the last name of the author: two authors (Habbe & Hartono, 2000); more than five writers (Boediono et al., 1999); several sources of quote from various authors (Mardiyah, 1991; Kusumawati, 2013); multiple citation sources from the same author (Djakman, 1998, 2000); one author (Syafrudin, 2001).
- 2. Write the quotation with the letters a, b,.. after the year if the bibliography includes an author who wrote many articles in the same year. (Joni, 2014a; 2014b) or (Joni, 2014a; David, 2014b) are two examples.
- 3. If the author's name is mentioned in the text then the writing is: "Alamsyah (1998) states...." incorrect writing: "Alamsyah (Alamsyah, 1998) states....."
- Quotation sources originating from institutions mention the institution's acronyms, for example (IAI, 2014).


