SCOPE AND CONTENT

This collection contains materials donated by OPAL to Shorefront Legacy Center shortly after OPAL disbanded in 2022. Paper materials include FOIA requests, FOIA documents, OPAL newsletters, OPAL's Facebook page posts and pictures, educational resources for members and meeting attendees, education proposals, biographies of OPAL's board members, and speaker notes and remarks. The collection also houses non-paper collateral, including OPAL t-shirts, buttons, flyers, a face mask, and an award for Rev. Dr. Michael Nabors.

BIOGRAPHICAL / ADMINISTRATIVE HISTORY

OPAL was a nonprofit founded in 2014 by members of Evanston's Black community. Its lead founder is Cicely Fleming. OPAL's mission was to achieve racial equity in Evanston through advocacy, voter education, civic engagement, and candidate development by: engaging and equipping Evanston residents to actively participate in the decisions that affect their lives, working to ensure that leadership reflects and prioritizes racial equity, and working to amplify the voices of Evanston residents who have been under-represented. OPAL used both public methods and private advocacy to pursue its objectives. OPAL focused on improving Black student achievement in Evanston/Skokie School District 65; electing equity-focused candidates to the District 65 school board, the ETHS District 202 school board, and the Oakton Community College Board of Trustees; and racial equity in Evanston City government. The letter vigorously objects to the City Council's attempt to initiate a process to hire a City Manager without following the public, transparent process agreed to on February 24, 2020. The letter ends with a signed petition that calls for citizens to be involved in the search for a City Manager.
