RECORDS TO BE CHECKED, PROCESSING FLOW, POINTS OF ATTENTION

Application

In the application driver should mention which type of tractor/trailer he used to drive. No class B vehicle should be counted as the cdl experience.

- ✔ Driver changed more than 5 companies during the last year;
- ✓ Driver has big gaps in cdl class A experience;
- ✓ Driver has not been working as a cdl class A driver for the last 1-1.5 year.

If a driver mentioned termination from any of his previous companies – pre-employment verification should be done.

If a driver is mentioning that Hi/She has been tested positive – not qualified. Any accident indicated by driver in the application as his/her fault (accepting if the accident happened on a private car – case should be discussed separately);

PSP

If the PSP record is not showing any information – pre-employment verification should be checked.

If Pre-employment screening is showing any of the below results:

- Terminated due to safety reasons;
- Accident
- Abounded equipment;
- Left the company without 2 weeks' notice.
- Driver is not able to provide the police report on the accident indicated in the record -

If one of the above mentioned - Driver is not qualified.

MVR

MVR (Motor Vehicle Record) - summary of a driver`s convictions and accidents on file with his/her home state. Record is showing any violations/accidents on a private vehicle. Records should be ordered through the Tenstreet system.

In case if any MVR record cannot be ordered by Tenstreet due to a specific state, this should be requested by email to the safety department.

On MVR Check if:

- MVR record is shown as invalid or inactive
- _ Restrictions, Endorsements
- If a medical card is Non Excepted Interstate, if matched actual medical card
- _ In case if the paper copy of medical card is not expired but the record is not showing this information, driver should update it by DMV (Department of Motor Vehicles)
- Driver is meeting company Hiring Criteria
