Attorney Sullivan stated that the resolution needs to be amended to revise the reasons for rejecting the two lowest apparent bidders. The apparent lowest bidder, All General Contracting Corp. is rejected due to lack of public works certification and mathematical errors causing the bid to be significantly higher. Reliance Home Remolding does have the public works certification so that will need to be removed as a reason for rejection. The reasons that Reliance is being rejected is due to being non-responsive, no experience and no response from references. The resolution will be amended to reflect all the reasons.
