### **Justin Bieber Is Innocent**

I have decided to organize evidence, alibis, documentation, etc. that proves Justin Bieber's innocence within the recent allegations that he is a rapist along with an abuser. This is completely false and he should not have these claims associated with him. Rape is a serious topic that effects people daily. This not only affects victims within the moment, but also affects them during their day to day lives after the fact. Take it seriously and **believe victims no matter what when they come forward**. Also note: screenshots can be faked so it is important to note that ***all of the evidence provided in this document has also been screen recorded***. I just cannot include videos within the document.

On June 20th, a twitter user named @danielleglvn tweeted her experience with Justin Bieber which discussed how she was raped by Justin. The following is what she stated:

After hearing about Gabby's story with Ansel, it gave me courage to share mine. So this is a thank you to Gabby.

My name is Danielle, and for personal reasons, i will not be stating my last name. I'm posting this anonymously because i'm not ready to come forward and reveal myself. If he comes across this, you know who I am. I know you remember me. I hope your life is hell after this and you drown in guilt. On March 9, 2014, I was sexually assaulted by Justin Bieber. Justin was with his former ex-girlfriend, Selena Gomez, for a concert in Houston, Texas. Me and my two other friends heard Scooter Braun was having an event at Banger's Sausage House and Beer Garden that Sunday night in Austin, Texas. Performers like Cody Simpson, Tori Kelly, The Wanted, and more were attending the event. Then, later that night Justin Bieber surprised the audience with about 100 people at the bar and performed a few songs. He publicly dedicated a few to Selena. My friends and I were enjoying ourselves the entire night. A man then approached me and my friends and asked us if we would like to wait after the show to meet Justin. Of course we said yes. My friends and I thought it was strange at first and sketchy, but as promised, we all waited after the show because we were fans. Justin came up to us, we took some pictures and chatted for about 20

Hollywood stuff. Keep in mind this was in 2014, around the time where he was "out of control." Our small kisses then turned into a steamy make-out session. He had pushed me down onto the bed after about 10 minutes of sitting up, got on top of me, started kissing me down my neck and made his way down to my stomach. He found my jeans, unbuttoned them, removed them, and started tracing my underwear with his fingers. My thoughts then started to roam around my head and I started to second guess myself. I kept asking myself, "What about Selena?"; "Did I consent to this?"; "How will she react if she finds out?"; "Where are my friends?"; "How is this normal and okay?"; I told him that this was going too far and that we should stop because I needed to find my friends, most importantly because I felt guilty about Selena. That's when he told me: "Relax. They're all okay." He then pulled my underwear down, unbuckled his pants, pulled his underwear down, grabbed the bed covers, and threw it over us. His body was on top of mine, skin-to-skin. I was very uncomfortable, and I felt myself starting to hyperventilate. I told him to get off because I was starting to worry about my friends, but it was too late. He forced himself inside me before I got the last few words out. He was thrusting in and out me. As I laid there, speechless. My body felt unconscious. I don't want to go into detail about what happened next. Although, this was 6 years ago, although I was

Although, this was 6 years ago, although I was one year older than him (he was 20, I was 21), I was still sexually assaulted without consent. Fast forward to late last year, I finally decided to speak up about it. I told my close friends and my immediate family. It was hard, but I finally got to tell my story. If you've ever been a victim of sexual assault, I believe you. You and your story matter. You are valid. You are heard. I will stand with you. What happened to me was not okay. It took me YEARS to finally speak up about it, but it is never too late to do so. Just because he is a huge pop star with a lot of money and millions of fans, doesn't make this okay and should go unnoticed. I am still recovering. Attending multiple therapy sessions, seeking help, and talking to people. Thank you for listening to my story.

Key information from this accusation include:

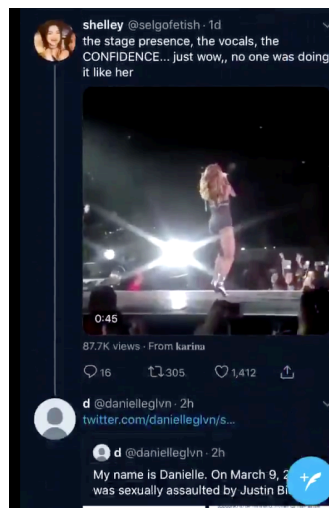
- Date it occurred: March 9th, 2014
- Location: Houston, TX
- Event location: Banger's Sausage House and Beer Garden in Austin, TX
- Some other performers included
  - Cody Simpson
  - Tori Kelly
  - The Wanted

After her main statements, @danielleglvn continued to discuss more things such as it occurring at the Four Seasons **Hotel** in Austin, TX. *It is important to understand she stated it was at the hotel for future evidence that will be shared.*

Starting off, something that was suspicious was that the day before this was tweeted by @illumigomez:



And when @danielleglvn's account started it was followed by Selenators along with mass promotion under tweets.



(Now, this part is not confirmed evidence, but I think it is important to state everything that was circulating regarding this. There is no evidence Selenators were behind it at all, but again it is important to give all aspects of what surrounded the accusations.)

Once she made her allegation, evidence began coming up that did not line up with what she was saying. A tweet by @ErinALynch from March 10th, 2014 came up that stated:

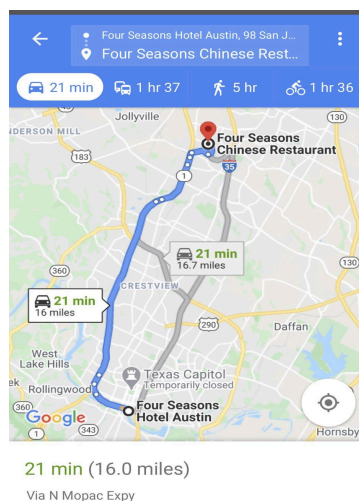


People began running with this thinking that it proved Danielle's story. That was until Erin herself tweeted the following:



From this tweet you can see that she saw him at the Four Seasons **restaurant**, *not the hotel*.

The Four Seasons restaurant is located about 20 minutes from the actual Four Seasons hotel.



Other people were saying Justin was at the Four Seasons Hotel due to the fact @JustinHerman tweeted stating he saw his “yellow Lambo” there. (Also... why do people still spell his last name “Beiber” ... baby do a Google search... pls.)



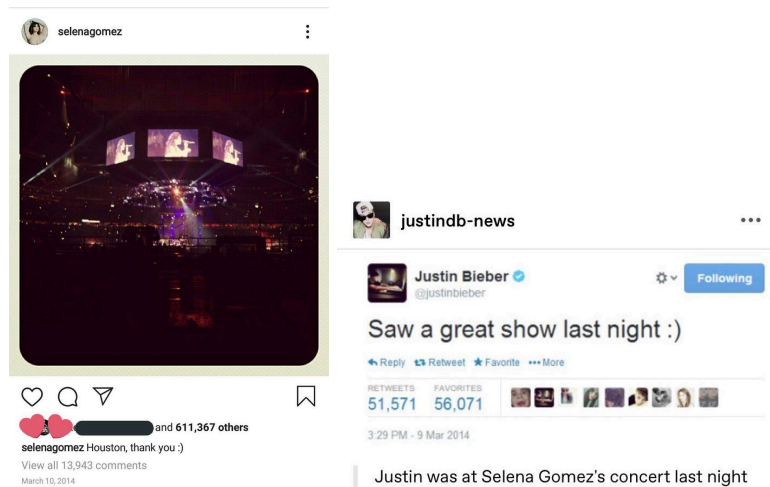
Now Justin did have a rented yellow Lamborghini (it was the car he was arrested in on Jan 23, 2014 and the only time he drove it). The Four Seasons prices per night can range to upwards \$1000 a night so they cater to a customer that is wealthy and many people that stay at that hotel could afford a “yellow Lambo.”

This is also proved to be incorrect as Justin actually had his cheetah print Audi R8 while in Texas.





Justin came to Texas with then girlfriend, Selena Gomez, for her concert at the Houston Livestock Show and Rodeo.



Several people also tweeted about seeing him at the show



Before the show he was at a dance studio.

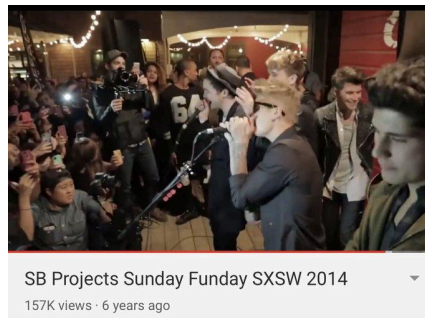


They were also spotted together there before the show. @Makdaddy95 also tweeted how his dad was escorting them around the Houston Rodeo.



(“#perksofbeingacop” ... I’m puke. ACAB!!!)

Afterwards, Justin decided to do a surprise performance at the Scooter Braun Projects Sunday Funday Showcase during SXSW. They did not arrive there until late that night and people were unsure if he would even show and he didn’t until around 11PM.

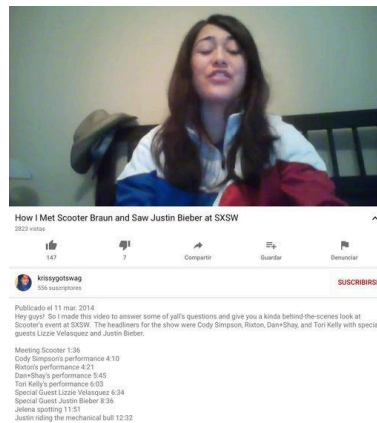
The article also states “*Justin and Selena were together the whole time*” and “sitting together, hanging out, and very friendly together.”

Other information has also have come up in regards to the timeline.

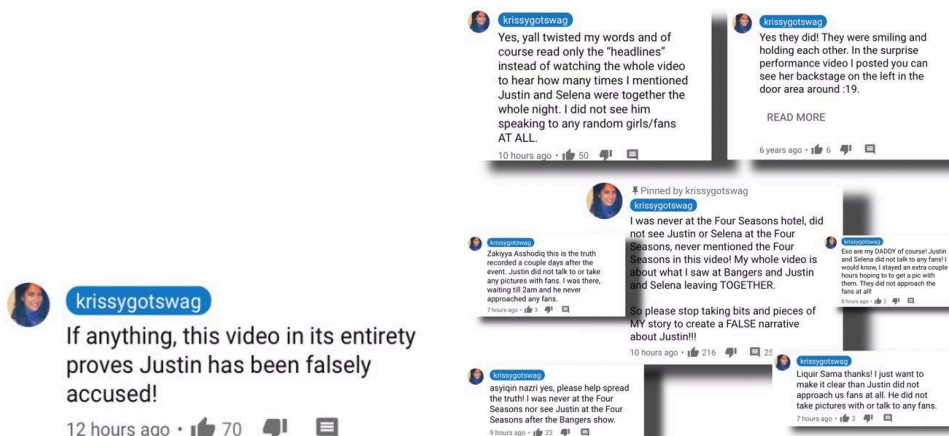


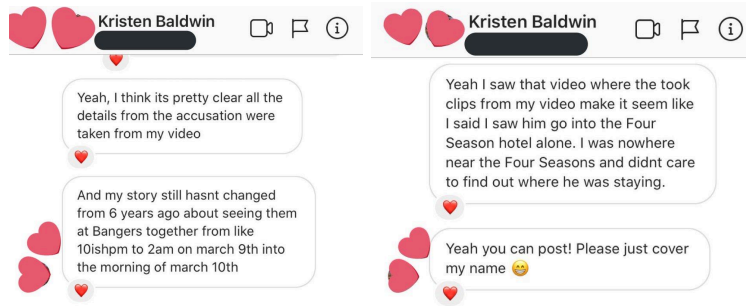
There was also a video posted by krissygotswag on YouTube explaining her story of the night which was uploaded on March 11th, 2014.

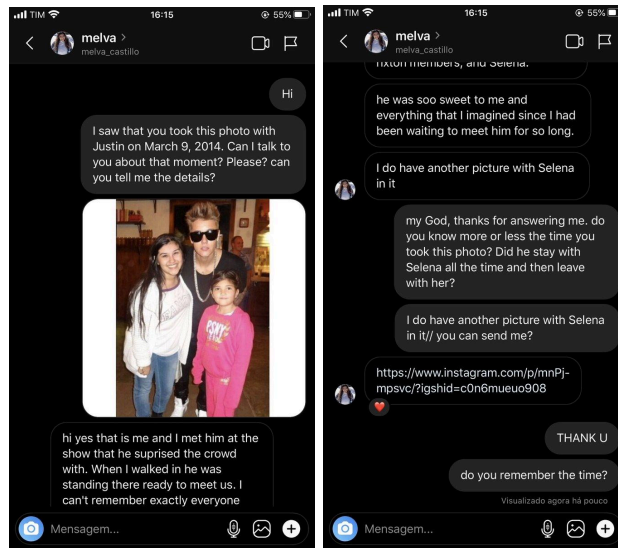


Since the accusations she has gone on to comment on the video discussing how Justin never approached any fans and she was there for several extra hours after the event waiting for him.

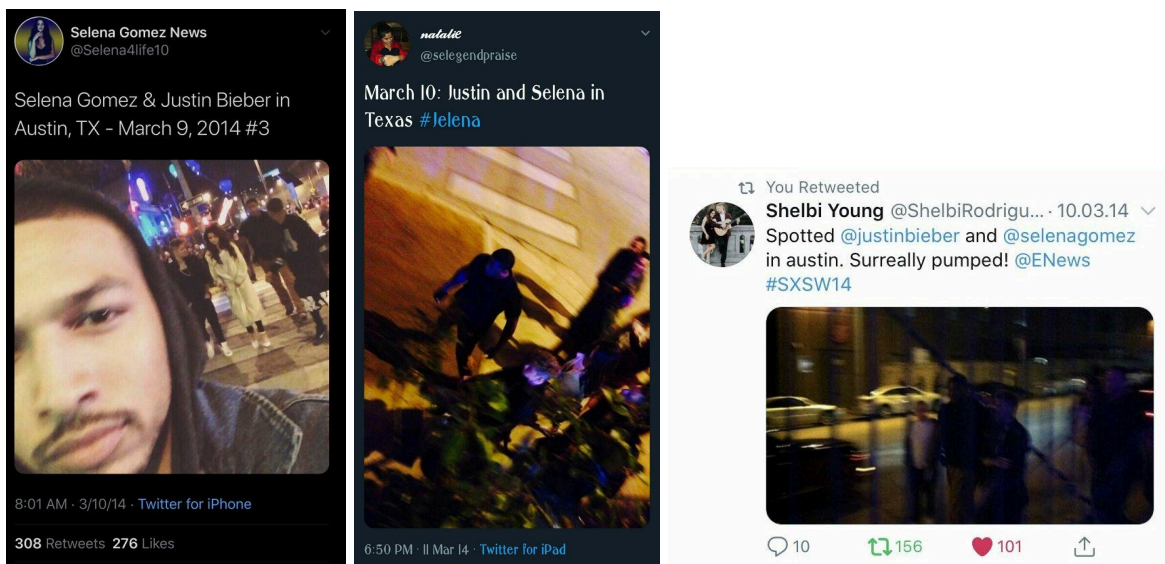




Krissy also stated how this was the only girl to meet Justin at the event that night:

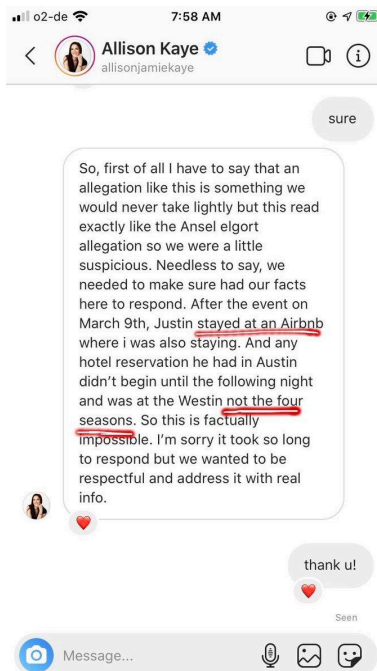


After the event Justin and Selena were spotted walking around the streets of Austin, TX.

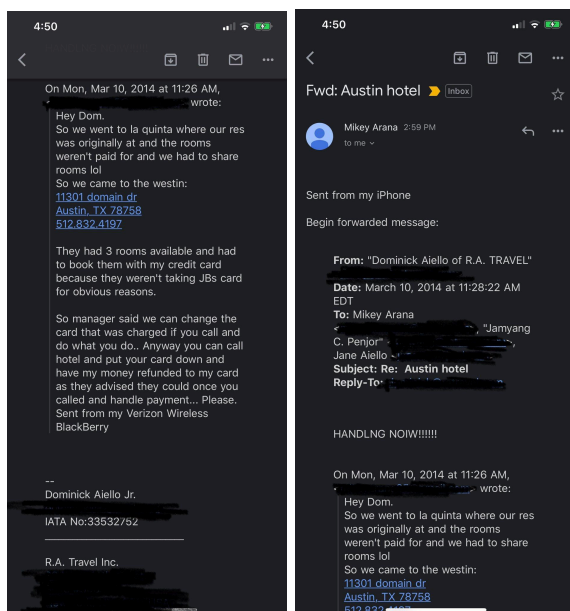

Now going into where Justin was actually staying. Once accusations began, people from the fandom reached out to Allison Kaye who works for Justin's team. She replied stating Justin stayed at the same Airbnb she was at on March 9th. **Any hotel reservations he had did not start until the next day on March 10th.** They also stayed at the Westin, *not the Four Seasons*, due to their booking at the LÀ Quinta being messed up.

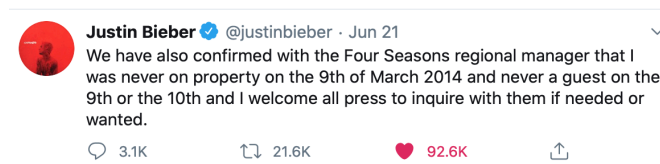


There are also actual hotel receipts along with documentation to prove this statement correct.

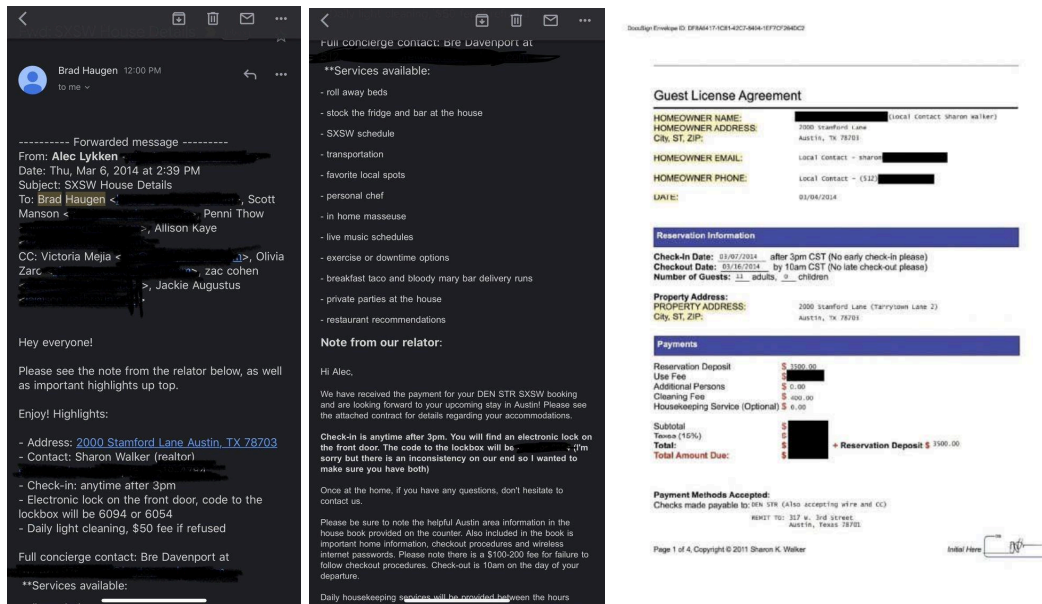




He also confirmed that they were in contact with the hotel and confirmed his whereabouts.

@tmcleod3 on Twitter also confirmed he stayed at the Airbnb as he went there himself along with playing basketball with Justin the morning of March 10th.





On March 10th, Selena left Texas for work. Justin stayed at the Westin with the rest of his team.

For those who do not know celebrities usually use an alias when booking things for privacy reasons. You can look up “celebrities alias” on Google and find other celebrity aliases that they use.

His booking was until the 13th, but he decided to leave early on the 11th.

People have also dug up this tweet from @charolyn\_ stating she saw “jb” at the Four Seasons in Houston, but has since replied stating she meant “Ms J. Buss”



There are also photos of him with his crew inside the Westin

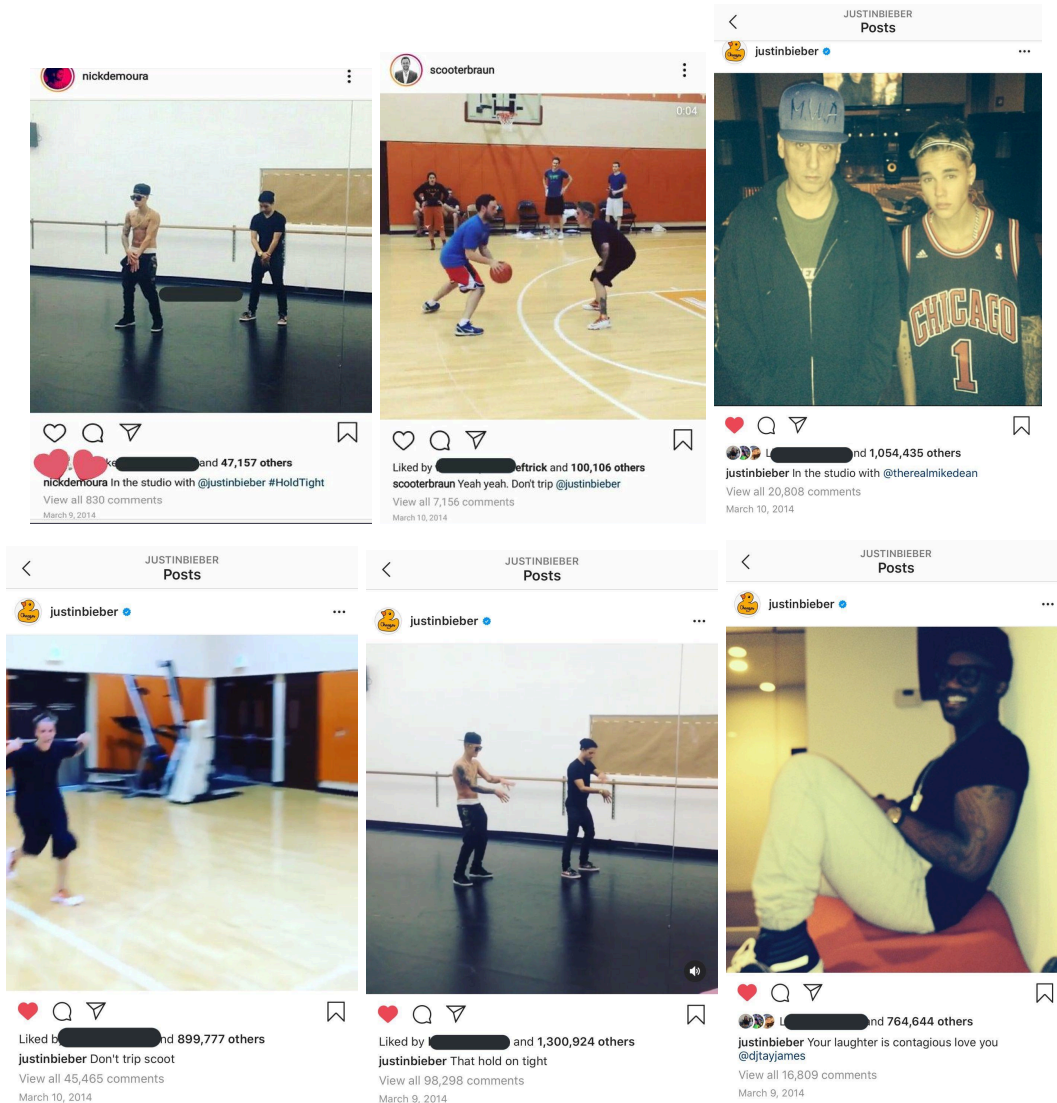

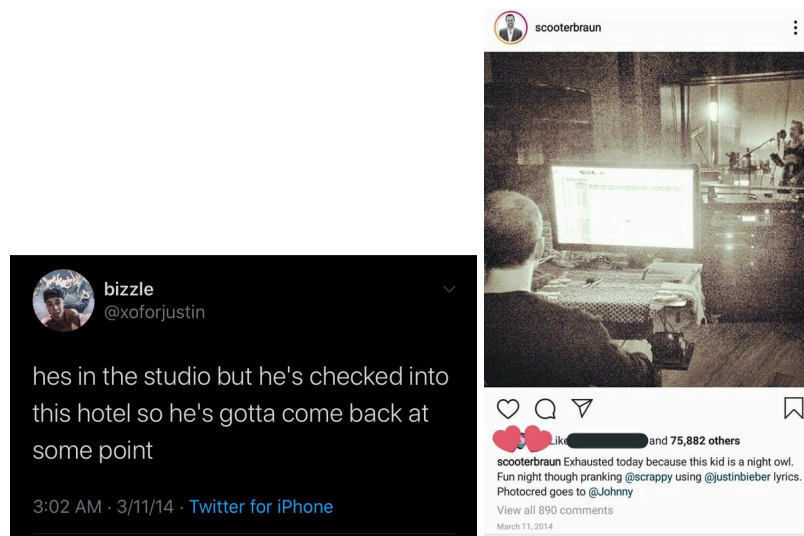
He was also spotted at the hotel by @DavidJohnson



There are also several photos and posts confirming his locations during his stay in Texas.

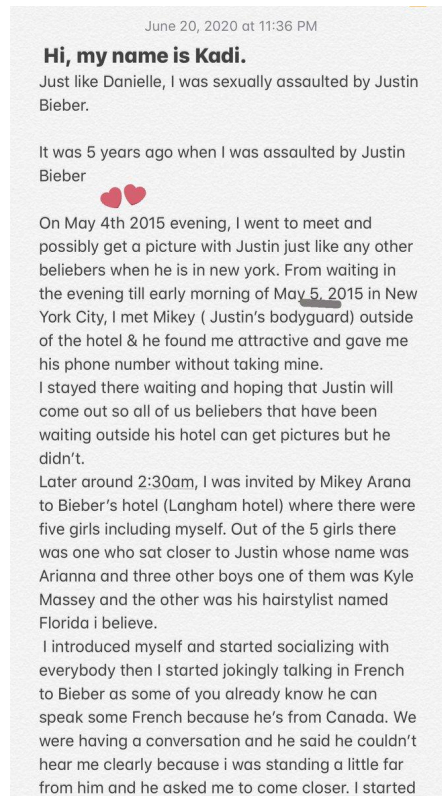


Also before his departure on the 11th he went to the studio in TX.



With several pieces of documentation, tons of alibis, photographs/videos of his location throughout the trip along with fan sightings of him with Selena together all night **there is absolutely no factual way he could have ever been at the Four Seasons in Austin, TX.**

Moving onto the second accusation that came from Kadi (@ItsnotKadi).






Her story was much easier to debunk right off the bat.

Kadi claims the assault took place around 2:30 AM on May 5th, 2015 in NYC. Right away this can be easily debunked.

May 4th, 2015 was the Met Gala that Justin went to.

This alone can debunk Kadi's statement as he was out from the point he was at the Met Gala to Rihanna's party to getting hot dogs at 4 AM. There are several pictures and videos that confirm his location throughout the night.

There are even articles discussing how late he was out.

Seeing as this get-together happened at Up & Down, you can imagine how late—or early morning—it must have been! According to our source it quickly went from an after party to an after-after party LOL. As the night progressed, Bieber also was spotted with his mentor, **Usher**, and gal-pals **Hailey Baldwin** and **Shanina Shaik**. **Madonna** even made an appearance at the "Bieber table," according to our source.

If this alone does not confirm her story is false, there are also tweets from Kadi from the past couple of years that are not only concerning, but also show her tweeting him about meeting in the streets along with tweets that go all the way to 2020. Once people started finding these, she began deleting them. There are still screenshots along with screen recordings proving these tweets. Some are also still up.

Now Kadi has met Justin once before on September 10th, 2014.

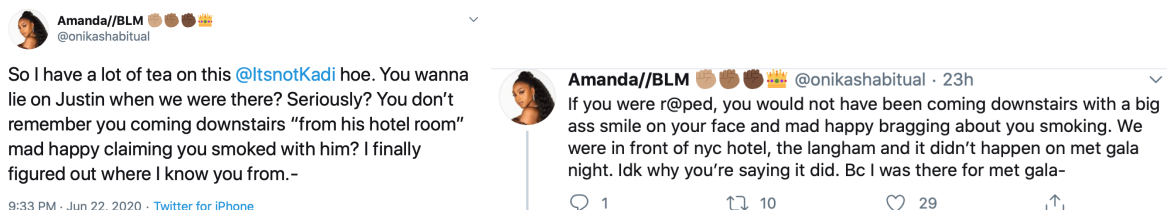

Another person also came forward, @onikashabitual, who had met Kadi:



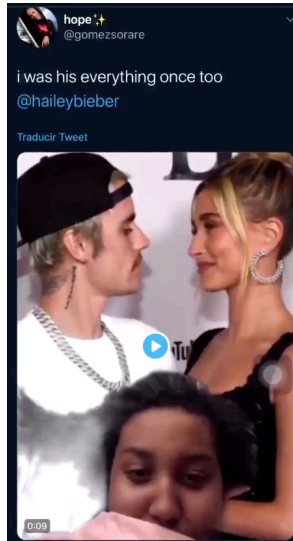

Recently she made a Tik Tok recently saying how she was his “everything once too” which makes no sense to her accusation.

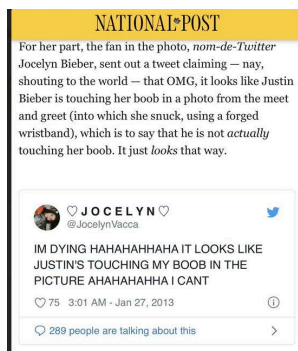


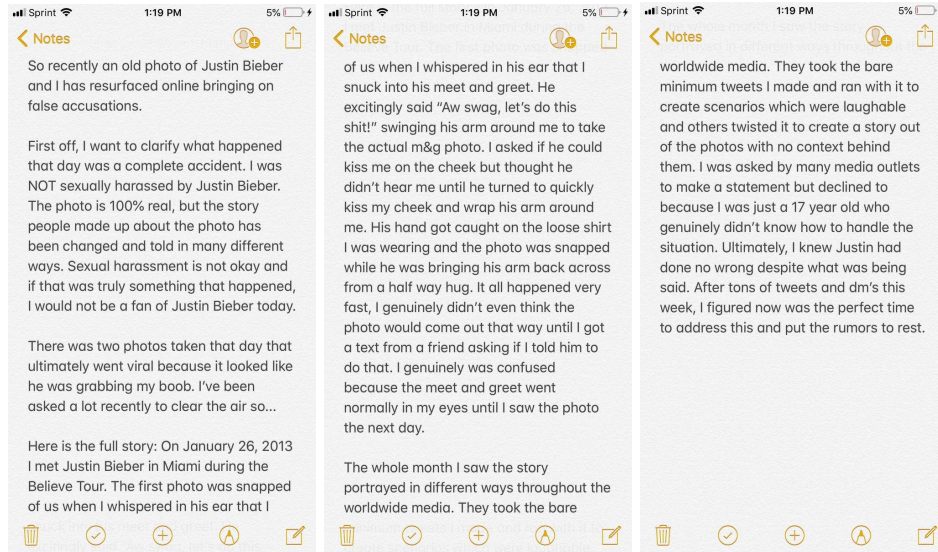
A lot of people have also been circulating this image from his meet and greet during the Believe Tour and trying to use it as “proof” he inappropriately touches fans during meet and greets.



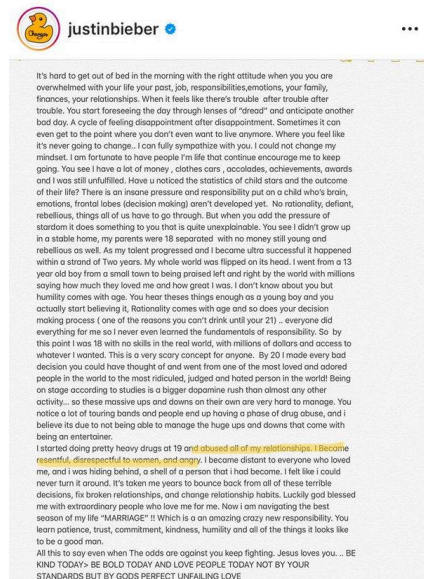
People are spinning the narrative of this image and it is completely, beyond far from the truth.

The girl in the image is @JocelynVacca. She herself has even tweeted how she **told him to do that multiple times**.





Another statement people are trying to pull is from a statement where Justin described that he used to “abuse his relationships.” This statement is also being completely twisted. By abusing his relationships he did not mean domestically. Is abusing relationships correct to do? Never. That is his mistake completely in which he has owned up to himself. These were also not only romantic relationships it was friends and family. He was in a very dark place during this time period, abusing drugs along with other things that lead him to almost dying.



What we also are not going to do is blame being an addict on “raping” people. Being an addict does not equate to being a rapist. Yes doing drugs makes you do things you may not do when sober, but it does not make you a rapist. Anybody who has a friend, family member or whatever who is an addict can agree with this. It is a very dangerous mindset to have and creates an even bigger stigma against addicts.



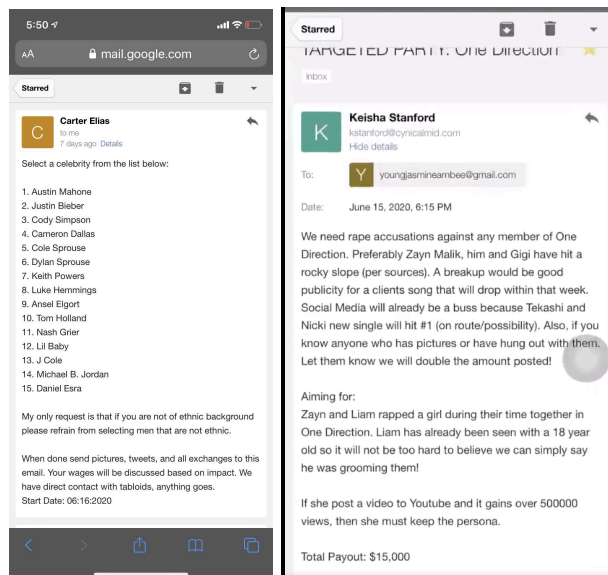
Now moving on to possible explanations for these accusations.

Keep in mind the following are just *possible explanations* and nobody knows the actual truth on why these accounts falsely accused Justin other than being twisted individuals.

Within the last day an account with the user @cynicalmagcon appeared on Twitter which has been exposing an industry where people make money off of ruining peoples careers/reputations.

@cynicalmagcon has stated how they have done this in the past and was hired to ruin a company's reputation, but they never accepted a job that dealt with rape.

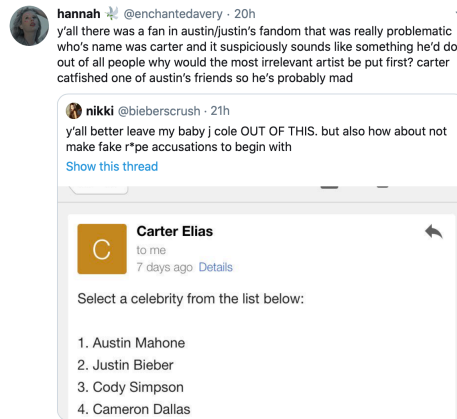
They began tweeting emails that expose this industry.



There are also other tweets in regards to this, but they do not all reference Justin and we are just speaking on Justin's situation.

A lot of people wondered if this could relate to someone who used to be in the fandom.





Again, this is not confirmed, it is just being shared because all aspects need to be put out there. Another thing that has been brought to attention is Justin's "look alike," Jordan Taylor, who goes by AlmightyJBizzle.

If you do not know who he is (you are lucky), Jordan has been impersonating Justin for years and even got every single tattoo Justin has.



Although this clown bag looks nothing like Justin, not even his toenail clippings, someone younger may not know that. Especially if he is not saying directly that he is not Justin. Think about it. What normal person gets EVERY tattoo Justin has? Not many. So when someone sees that, they may be fooled.

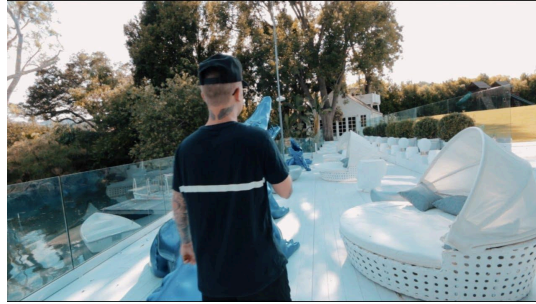

Jordan even started drama back in the day for the clownery he pulled pretending to be Justin.

Jordan basically got into the parking garage where Justin valeted his G-Wagon by pretending to be Justin. The person who was running the valet did not notice, gave Jordan Justin's keys and allowed him inside the parking garage. He also sat in Justin's car and drove it.



Jordan also snuck onto Justin's old property in Toluca in 2017 and walked around.



Both of these instances were filmed and posted on Youtube for all to see.

**It is easier to say sorry to whoever was falsely accused than dismiss a real victim.**

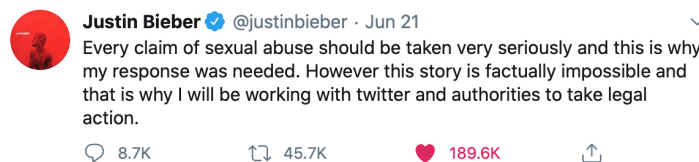
Also, a lot of people have also claimed Justin could be paying people off.
