## Terms and conditions SIB Charity Gala

### *Gala*

1. When the registration form is sent, you declare that you have ordered a gala ticket
  - a. For yourself, or
  - b. For you and a date, a member of SIB-Leiden, SIB-Utrecht, SIB-Groningen or SIB-Amsterdam, or
  - c. For you and a date, not a member of SIB
2. If you bring a non-member of SIB with you, please note that the SIB-member is completely responsible for the behaviour of their date. Consequently, any misconductive acts during the gala by a non-member will lead to the sanctioning of the SIB-member and the external date.
3. The price for a gala ticket is €30,00 per registered person, for members, and €35,00 for non-members of one of the four SIB associations.
4. Any profit made with the sales of tickets will be added to the total amount of the charity auction.
5. The purchase can be cancelled until **March 22, 2024, 12:00 at noon.**
6. The purchase can only be cancelled via an e-mail to [sibbenefietgala@gmail.com](mailto:sibbenefietgala@gmail.com). Mails sent to another e-mail address, or any message not sent via e-mail, are considered unreceived.
7. Mails sent after March 22, 2024, 12:00, that are particularly meant for cancellation without a valid reason for you or your date, are considered unreceived.
8. Valid reasons for cancellation after this date are determined by the Benefietcommissie and the SIB-Leiden board.
9. You will be made identifiable at the door of A.L.S.V. Quintus. The doors of the gala close at **22:00**. After that time, you are unable to receive a stamp and will not be able to enter the gala without a valid reason that has been corresponded with your local board before **April 5, 20:00**.
10. Once you have a stamp, you may leave and re-enter the building until **01:00**.
11. You adhere to the following orders:
  - a. Rules set by the Benefietcommissie of SIB-Leiden, and
  - b. Rules set by the boards of SIB-Leiden, SIB-Utrecht, SIB-Amsterdam and SIB-Groningen, and
  - c. The House rules of A.L.S.V. Quintus and the Quintus personel
12. House rules and additional information will be given at the latest on **March 29, 2024, 17:00**.

### *Charity Auction*

1. A final bid on an item at the charity auction is binding. Once you have won an item, you may be ordered to fill out your name with the gala committee.
2. Once you have won an item, you will be ordered to a delegation of the gala committee to leave your bank details.
3. You can only enter your own bank details. Registering someone else is considered against the rules and may lead to sanctions during or after the gala by the committee or local SIB-board.
4. The amount you have bid will be deducted from the registered bank account within 30 days.
5. Retracting the offer after gaining the winning bid is considered against the rules of the auction. Please note that if you retract your offer, the committee and SIB-boards reserve the right to sanction you during and after the gala.
6. If your bank details do not match or lead to an error when deducting the amount, you will be contacted after the gala.
7. Entering false bank details is considered against the rules of the auction. Please note that if you deliberately enter wrong details, the committee and SIB-boards reserve the right to sanction you during and after the gala.
