

Privacy Policy for Mic Live Karaoke, Announcement with lowest DELAY

This Privacy Policy describes how **Mic Live Karaoke, Announcement with lowest DELAY** (the "App") collects, uses, and protects your information when you use our app, which turns your phone into a microphone when connected to a Bluetooth speaker. The App is provided by **zerowing** ("we", "our", or "us"). This policy is designed to comply with all applicable Google Play Store requirements.

1. Information We Collect

No Personal Data:

We do not collect, store, or transmit any personal information.

Microphone Access:

The App requires access to your device's microphone to capture audio in real time. This access is solely for converting your phone into a functioning microphone and is active only while you are using the App. No audio is recorded or stored.

Bluetooth Permissions:

The App requires Bluetooth permissions to connect to and interact with Bluetooth speakers. These permissions are used exclusively to establish and maintain the connection and do not involve the collection of any personal data.

2. Use of Information

Local Processing:

All audio processing occurs locally on your device. The captured audio is used solely for the purpose of enabling microphone functionality and is not transmitted to any external servers or third parties.

No Data Transmission or Storage:

Since no data is stored or transmitted, there is no risk of your personal information being shared or misused.

3. Data Sharing and Disclosure

No Third-Party Sharing:

We do not share, sell, or disclose any information to third parties. Since no personal or sensitive data is collected, stored, or transmitted, your privacy is maintained.

4. Data Security

Security Measures:

Although the App does not collect or store personal data, we implement industry-standard security practices to safeguard the data processed in real time. Please note that no method of electronic transmission or storage is completely secure.

5. Children's Privacy

Not Directed to Children:

The App is not intended for use by children under the age of 13 (or the applicable legal age). We do not knowingly collect any personal information from children. If you believe that we have inadvertently collected such information, please contact us immediately.
