- On November 27th the federal court held the city in contempt for failing to address

- As the federal court is on the verge of receivership, it is important for the City Council to

- At least **33 people have died** in the custody of the New York City Department of Correction under Adams's watch. The DOC and the mayor are unwilling to address the long-standing issues plaguing the jail system.

Calls for federal receivership have grown with nearly 100 community groups, over 20 City Council Members, dozens of state elected officials, NYC Comptroller and Public Advocate, the NY Attorney General, and two former DOC Commissioners calling for a federal takeover.
