

Divorce Mediation - The New Alternative

As an alternative to each partner having their own attorney, each person represents themselves with a third person, who is neutral, acting as a facilitator. They have the opportunity to have each aspect of the divorce reviewed, and they are able to come to an agreement over the conclusion of the marriage together.

Its biggest advantage is that it allows the couple to be in charge of their divorce process. Mediation can allow a couple to make an agreement which suits both parties.

Divorce mediation is successful. Mediation, as shown through numerous studies, is as effective as a divorce through traditional means. Divorce mediation isn't compulsory, and there's always the option to go to court if it doesn't work out.

A mediator does not act as an attorney for either party, or for both parties, but is, nevertheless, usually a licensed Attorney. Instead, mediators give each party the information needed to decide legal issues; information is given only when both parties are present.

A divorce mediator should be a neutral party who does not take sides or instigate problems. Hiring a mediator does not require paying a retaining fee. Mediators will charge by the hour for their services. Legal documents are billed as a flat fee. Mediation fees are charged according to the services used, instead of paying a retainer to a lawyer.
