

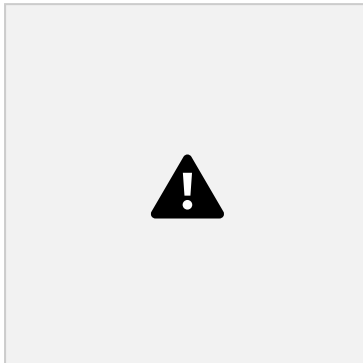


Figure 2 example (use times new roman with 8 font size and make align left)
