# **Terms of Use**

These Terms of Service grant you the permission to utilize the software applications, websites, tools, and other features (collectively referred to as the "Services") provided by Thermal Vision: Heat Nightcap. By accessing or using any of the Services, you agree to adhere to these Terms. Any third-party services you may use are subject to the respective third-party terms of service.

If a user submits a refund request for an in-app purchase, we reserve the right to share details with Apple regarding the user's in-app purchase activity. This may include the following information: time elapsed since the app was installed, total app usage duration, anonymous account identifier, whether the refunded in-app purchase was fully consumed, whether it included a trial period, the total amount spent, and the total amount refunded.

Certain features and aspects of the Services may be governed by additional guidelines, terms, or rules. These supplementary terms will be closely related to and dependent on the specific Services they pertain to. ## 1. Rights of the Parties
