

☆ Terms of Service ☆

By doing business with me and/or buying commissions, you are agreeing to my TOS.

If you spend someone else's money (ex: a parent, friend, or such), I am not liable. If you are using someone else's money, make sure you have permission:)

I Have the Rights to:

- Refuse or decline a commission.
- Cancel/refund your commission at any time with just cause
- Update, edit, and change my prices, as well as my ToS (what you paid will not change if I've already started your commission of course)
- Blacklist people from buying commissions. Blacklists are public and I do make my reasons known so that I can remain transparent.
- Post your commission on any of my social media. If requested I can wait to post until after you do as well or if you're using it for a secret project:D

Will Draw:

- Furies/anthro characters
- Fan art/fan made sonas/OCs
- NSFW
- characters/regression art (SFW)
- Mild to medium gore/blood, candy gore
- Complex backgrounds
- Couple art/multiple characters (+75% base price per OC)
- Props (may charge extra)
- Feral ocs (same rates apply)

What I Will Not Draw:

- Heavy mech/cars/etc (some mech is okay but im not experienced on very intricate mech designs)
- Anything problematic (ex; inappropriate relationship dynamics like proshipping, comshipping, aging up characters who are minors (especially in a suggestive way)
- Zoophilia, feral NSFW, pedophilia, politics, hate, racism, transphobia, homophobia, ableism, incest, so forth.
- ***Knots, animal genitalia in general including (animal) nipples in a sexual way-*** alien is fine and anything more "human" is fine.
- Anything else considered illegal and/or problematic.

NSFW:

☆ will not do any weird fetishes or kinks (ex; piss/scat kink, size kinks both in weight and height that's too extreme) if you're unsure then ask me.

☆ ***as mentioned I won't draw any form of animal genitalia***, it has to resemble something of a human and I will not draw feral NSFW of any kind.

☆ will not do any illegal NSFW, such as but not limited to minors or OCs meant to "appear" as below the age despite what their "actual" age might be

☆ an extra character will be +100% of base price

☆ If you lie about your age (Which I will be IDing for), I will also deny your commission and blacklist you.

☆ Feel free to use your commission for **pfps, posts, toyhouse, ect** but please properly credit me.

☆ If you make a badge I request you write my @ on the back if its not already on the drawing itself

☆ If you make any other physical copies of your commission you may NOT sell them or profit off my art in any way unless we have worked out a formal agreement, I **must** be informed and do not claim it as your own. If you're getting a commission with the intent of making stickers (ei; To hand out for free at cons) please let me know, I can add my @ to the bottom instead of an overlapping watermark so that it doesn't get in the way of the art, but again this must be thoroughly communicated and I do have the right to deny reproduction of my art so **make your intentions clear**.

☆ Commercial use will be granted sparingly and will come with an extra fee before you are allowed to sell or reproduce my art, *if* I've given the green flag to do so.

You May Not:

- Steal, trace, copy, or claim my work
- Use it commercially (unless previously discussed and agreed upon)
- If you end up selling the character, do not sell it more than the original price UNLESS there is added art of course.
- Profit off my art in any way.
- Reproduce it in any way (unless given explicit permission)
- Remove any signatures /watermarks.
- Use my art for NFT's and anything AI related.
- "Finish" my work (shade an unshaded project, ect..)

Payment

Payment is done in the American dollar - USD

Payments are to be made on time before any commissions are completed. I take PayPal, Kofi, or Stripe. If you don't have these payment methods that's okay, I can use Stripe and you don't need to make an account to pay:)

For simpler comms I may take payment first and for more complex ones I will take payment after the sketch is confirmed so I can calculate complexity if needed or if changes are made during the sketch process.

Refunds

Refunds can be issued anytime before the lineart is approved.

Refunds will be 80% back to cover fees and time spent on the commission.

Refunds will not be issued after the lineart is approved unless there is an issue on my end.

Charge backs without communicating first will lead to getting blacklisted.

Changes to Work

I will not make any major changes after the sketch/lineart steps, only minor if I missed something (my error) or a color is wrong, ect but no big changes like changing the pose after lineart has been accepted.

Boundaries & TAT

- My turn around will be 2-6 weeks unless it's custom/larger than what I publicly offer (ex; T-PNG tuber files, very large reference/OC sheets, complex scenes, things like that may take 1-3 months so I can get it right but I tend to be on the quicker side unless busy)
- I will inform you if a project will take longer as communication and clarity is important to me.
- Trying to pressure/harass me to get a commission done quicker can result in cancellation of a commission. If it is needed by a deadline or rushed I may charge a small fee after we discuss it:)
- Please keep chats professional, there is no need for rude behavior, flirting, sexual comments, sweet names, ect. as it makes me uncomfortable. You may, however, discuss your characters or story as I work on your commission.
- You are allowed to ask for updates once I accept your commission, and you are allowed to see the time taken for the drawing.

To stay up to date I will also have a Trello link in my Carrd where I will update with any new comms ive taken and where I'm at in my queue. I try to update it as frequently as I can.
