Agenda: Motion was carried unanimously to approve the agenda as distributed.

**President's report**: Stan: Nothing new to report.

**VP-Administration report:** Wil has now renewed the SCGSD P.O. box and set it up to notify him when mail arrives. The P.O. box was closed and two letters had been returned. Those letters have now been delivered. Wil has also got a 2<sup>nd</sup> Key for the P.O. box (located at the Cass street P.O. in Pacific Beach), which he will give to Stan as a backup person.

**Treasurer Report**: Miriam stated that during February we received dues from 11 members for \$165, with PayPal expenses of \$3. Our balance, after expenses, rose from \$5027.99 to \$5189.83. The minutes from last month were sent to the Bank, and the signatory changes are being processed by the La Mesa branch. Miriam is now pursuing our 501c3 renewals, and hopes to have them complete by next month. This month's treasurer's report was accepted unanimously.
