Introduction

USDT mining : Cloud USDT miner is provided as a free application ("Service") by us.

This privacy policy explains how we handle personal information when you use the Service.

By using the app, you agree to the collection and use of information as described in this policy.

Information Collection and Use

For an improved experience, we may request personally identifiable information, stored locally on your device and not collected by us directly.

The app uses third-party services that may collect information used to identify you.

These services may include:

- Google Play Services
- Google Analytics for Firebase
- Firebase Crashlytics
- One Signal

Log Data

In case of an error while using the app, we may collect data and information (through third-party products) called Log Data.

This may include your device's IP address, name, OS version, app configuration, usage timestamp, and other diagnostics.

Cookies

Cookies are small data files used as anonymous identifiers.

While the app itself does not use cookies, third-party tools integrated within the app may use them to collect data and improve services.

You can choose to accept or refuse cookies via your device settings.

GDPR Compliance

We comply with the General Data Protection Regulation (GDPR) for users located in the European Economic Area (EEA). Any personal data collected by our app is processed solely for essential app functionality, analytics, or advertising purposes as permitted under GDPR. We do not collect or store sensitive personal information, and all data is handled securely according to applicable privacy laws.

Consent Management (CMP)

Our application does not use a Consent Management Platform (CMP) and does not require any consent withdrawal options. We do not collect or use personal data for personalised advertising or profiling. Any data processed is strictly limited to essential service functionality and is not used for behavioural tracking or commercial targeting.

Third-Party Services

We may engage third-party companies for the following reasons:

- To facilitate our Service
- To perform services on our behalf
- To assist in analyzing app usage

These third parties may have access to your personal information strictly to perform assigned tasks and are not permitted to disclose or use the data for other purposes.

Delete Account

You can delete your Google Login Account or Email-Password Account in the application from the Settings section.

You will find the **Delete Account** button there.

We value your trust and are committed to protecting your personal data using commercially acceptable measures.
