Privacy Policy

Slavine ("Company," "we," "our," or "us") respects your privacy and is committed to protecting it through this Privacy Policy. This Policy describes how we collect, use, disclose, and safeguard your information when you visit our website https://slavine.store/, engage with our services, or attend our events.

By using our website or services, you agree to the practices described in this Privacy Policy.

1. Information We Collect

We may collect the following types of personal information:

- Contact Information: Name, email address, phone number, company or organization, and mailing address.
- Media Content: Photographs, video, and audio recordings taken at events we host or organize.
- Payment Information: Billing details necessary to process event-related payments.
 Payments are processed through third-party providers, and we do not store credit card numbers.
- Technical Information: IP address, browser type, device identifiers, cookies, and analytics data collected automatically when you visit our site.

We may also collect sensitive personal information, such as payment details or dietary/accessibility requirements for events. This information will only be used for limited purposes (e.g., processing payments or fulfilling specific requests) and will not be used for profiling or marketing.

2. How We Use Your Information

We use the information we collect to:

- Provide, manage, and customize our event services.
- Communicate with you regarding bookings, inquiries, updates, and promotions.
- Process payments and issue invoices.
- Improve our website, marketing, and overall customer experience.
- Capture, use, and share event media content for promotional purposes (see Section 5).
- Comply with legal obligations and enforce our terms of service.

We retain personal information only as long as necessary to fulfill these purposes, unless a longer retention period is required by law. When information is no longer needed, it is securely deleted or anonymized.

3. Cookies and Tracking Technologies

Our website uses cookies, pixels, and similar technologies to:

- Enable essential site functionality.
- Analyze traffic and user behavior via analytics tools (e.g., Google Analytics).
- Provide personalized content and marketing.

Some of these technologies may constitute "sharing" of personal information under California law, particularly for targeted or cross-context behavioral advertising. California residents may opt out of such sharing (see Section 7 below).

You may disable cookies in your browser settings; however, some site features may not function properly if you do so.

4. Sharing of Information

We do not sell or rent your personal information. We may share your data only in the following limited circumstances:

- Service Providers: With trusted third parties who assist with payment processing, email delivery, event logistics, or analytics.
- Legal Requirements: When required by law, regulation, subpoena, or court order.
- Business Transfers: In connection with a merger, acquisition, or sale of company assets.

Under California law, certain types of data sharing (e.g., for advertising or analytics) may be considered a "sale" or "sharing." We do not sell personal information for monetary value, but we may share limited data for these purposes. You have the right to opt out of such sharing (see Section 7).

5. Data Security

We use appropriate administrative, technical, and physical safeguards to protect your personal information against unauthorized access, use, or disclosure. However, no system is completely secure, and we cannot guarantee absolute protection of your information.

6. Your Rights

Depending on your jurisdiction, you may have certain rights regarding your personal data, including:

- The right to request access to the personal information we hold about you.
- The right to request correction or deletion of your personal information.
- The right to opt out of certain marketing communications.
