There were no free templates on the internet that mimicked Ms. Kennedy's Open Letter regarding Robert F. Kennedy. So I am sharing what I cobbled together. That document will be at the bottom of the list and has the original text from Ms. Kennedy in the body of the letter.

<u>The letters evolved to reflect the electronic submittal format</u>. The actual formal letter template was observed in the first couple of letters as well as the Sample Template that is the very last link on this document. Letters are mostly newest to oldest as you go down the list.

The #Contacts# link is to spreadsheets. There will be tabs at the bottom. The first sheet will be a phone view friendly. My android displays better in the landscape view. The other tabs at the bottom of the sheet will have more data.
