Separate each keyword with a semicolon (;) and NOT a comma (,). Key improvements and rationale:

RESULT AND DISCUSSION ← 12pt, Times New Roman, Bold)

The discussion of the obtained research results and findings is presented through theoretical exposition, both qualitatively and quantitatively. Experimental findings should preferably be displayed using graphical representations or tables.

CONCLUSION ← 12pt, Times New Roman, Bold)

The Conclusion must clearly indicate the findings obtained, their strengths and limitations, along with potential directions for future research
