5. [**UBAC Report \(Yang\)**](#)

Q: Are Educational Workshops open to others?

A: No, recordings are posted on the UBAC website after each workshop, and we can collect follow-up questions and submit them to presenters.

Q: Sept 14th UBAC meeting minutes do not match information presented today (for instance the tuition increase)

A: UBAC has made a recommendation, a memo is coming out later this week.

Q: What is the tuition increase?

A: UBAC has made a recommendation to Cabinet, and Cabinet will make the final decision. There was discussion during UBAC of increases in a range of 0-4.9% Members used rank choice voting to make their recommendation.

Q: Is there a workshop on the endowment?

A: There was one last year which you can view online. UBAC is also curious on how the endowment has increased this year. The committee has been told that the information is not available until the end of year.

Q: Will there be a discussion of capital projects?

A: We have requested a list of capital projects multiple times, via both direct emails and motions in UBAC.



Q: Why will there be \$1M cut in CAS?

A: At the end of the day we have a structural deficit. We are now in year 7 of budget cuts. Planning is required to get out of a structural deficit. We need a multi-year plan instead of just cutting each year. Currently it's estimated we have a \$13M imbalance for FY23. Last year's cuts were not as extreme as thought because of the federal stimulus. Also, last year management made many one-time rather than base cuts. There are many moving pieces such as tuition, budget assist, etc.

C: We need to do multi-year planning. In the past the admin has told us it's been too difficult. Given that individual colleges need a 5 year plan, why doesn't the University have a 5 year plan?

- a. Update on Ad-Hoc EV Charger Committee
 - i. 50 additional cards will be made available for people to charge their cars while at work. This is supposed to roll out at the end of this week
 - ii. A contract being pursued with Charge Point to open 15 new ports in Lone Mountain East
- b. Working with many members on discrepancies in pay, benefits, and contracts.
- c. There has been a cluster of members inquiring on workload issues, have been looking into how NTAs are credited or not credited

Q: How do we get around the structural issues of all these discrepancies?

A: There seems to be an overall lack of planning. All of our work is well done and will put pressure on to create more transparency and hold the administration accountable

C: The more we bring things to light and the more we communicate with each other in different spaces in the university, the more power it gives us.
