- VI. Treasurer's Report, Shane H. – had earlier emailed Feb Report
 - a. Beginning Balance – \$2,299.55
 - b. Contributions \$138.05
 - c. Expenses \$447.61
 - d. Reserve - \$1,350 - Christmas Alcathon (\$1000), workshop (\$250) and \$100 (Delegate Report Back)
 - e. Ending Balance - \$1989.99
 - f. Proposed \$1,000 Christmas Alk-a-thon, \$250 for a workshop, and \$100 to co-sponsor Delegate Report Back
 - g. Proposed Budget for 2025 is \$2,934, estimated 7th Tradition is \$2,100. Enough monies to cover negative.
