There will be two overflow tents in the back of the parking lot. Motion passed.
Another family eid is scheduled at 11:45. A family event at the zoo is being planned. Doors will open at 7AM and close at 7:30. 150 plus 10 volunteers per event. Ask people to come to the next event once the door closes. Police will be managing traffic. No registration will be required.

 - i. Driveway: There have been 6 meetings. The decision should come tomorrow. Clifton community has voiced support.
 - ii. Roof: All of the repairs over the years were not done correctly. We were told we need a new roof which is \$30-40k.
 - iii. HVAC will also need to be updated. Roof top units will need to be replaced as well.
 - iv. Parking lot repairs are required as well.
 - v. Zakat al fitr: 21k was given out last year. 14k of that was from zakat-al fitr.
