We strongly encourage authors to use the following abstract structured style, but without a title: (1) Background: place the questions discussed in a broad context and express the purpose of the research, (2) Method: briefly describe the research method, (3) Results: summarize the main findings of the article and (4) Conclusion: show the main conclusions or interpretations.

Introduction (Cambria 12 pt. font, Capitalize Each Word, Bold)

The introduction should briefly place the research in a broad context and highlight why this research must define the research objectives and its significance. The current state of the field of research and prior major publications must be reviewed carefully. Provide a broad definition and discussion about the topic and include the views of others (literature review) in the discussion to support, argue with, or show your position on the topic. Finally, the author briefly mentions the main purpose of this study and highlights the main conclusions. The research should be easily understood by scholars from other disciplines.

Research Methodology (Cambria 12 pt. font, Capitalize Each Word, Bold)

The research methodology section must include the type and approach of the research (qualitative, quantitative, or mixed methods), the location and time of the study, the research subjects or participants along with the sampling technique, the data collection methods used (such as interviews, observation, documentation, or questionnaires), the instruments used in the data collection process, the data analysis techniques applied to process and interpret the collected data, and the steps taken to ensure the validity and credibility of the data, such as triangulation or credibility tests (particularly for qualitative research).

Results and Discussion (Cambria 12 pt. font, Capitalize Each Word, Bold)

This section can be divided into several sub-sections, giving a concise and precise description of the research findings, interpretations and conclusions that can be drawn from the findings. Authors must discuss the results of the study which can be interpreted in the perspective of previous studies. The findings and implications must be discussed in the broadest possible context. Future research directions can also be highlighted.

Conclusion (Cambria 12 pt. font, Capitalize Each Word, Bold)

The section title must be "Conclusion," not "Conclusions." Give a discussion of the entire article coverage and concluding words. The conclusion contains the answers to the questions that have been asked in the research questions that are written briefly and clearly.

Acknowledgement (Cambria 12 pt. font, Capitalize Each Word, Bold)

This section allows you to thank all the people who helped you with the project. Write a thank you to the sponsor for research. Also write a thank you to the person who helped intensely in the research and writing of the article.

References (Cambria 12 pt. font, Capitalize Each Word, Bold)

References must relate to the material you cited in your article (not the bibliography). References must be in Reference Manager such as Mendeley or Zotero with *Chicago Manual of Style 17th edition (full note)* and listed in alphabetical order (do not include abbreviations). Every additional reference must be included in the additional reading section.

EXAMPLE:

It is your responsibility to ensure that all information in your paper taken from other sources is supported by quoted references in the text. Please also note that you do have to follow the *Chicago Manual of Style 17th edition (full note)*.

Note: The publisher can return your article for correction if you do not format your references correctly. Note that this will delay the journal publishing process. References must relate to the material you cited in your article (this is not a bibliography), and they must be listed in alphabetical order (do not include abbreviations).
