4. Stipend Appeals

- a. Budget committee decided stipends last wednesday and those that want to appeal that amount can
 - i. Senate recommends a number, exec board will need to approve
- b. Grace Wang: Received 90% of her stipend because she missed one senate, but doesn't believe that it impacted her constitutional abilities
 - i. As senior class president, she wasn't able to host traditional senior class events
 - ii. She has attempted to bond the class through several virtual activities and events to facilitate a remote community

- c. Discussion regarding Grace Wang stipend:
 - i. Johnson: Stipend was docked as an automatic deduction for missing three senates in a row
 - 1. Recommends that she receives her full stipend
 - ii. Max Dawson: Grace has done an excellent job with senior class programming, however she is constitutionally required to attend one in three senate meetings, and she missed four in a row. Not docking her 10% would be a direct violation of operating procedures.
 - iii. Sam Harrision: Just want to give some testimony that Grace has done a great job
 - iv. Max Dawson: Being on ASCMC for two and half years, no one has requested to appeal their stipend (for precedent)
 - v. Cristi Kennedy: On budget committee, they usually hear why somebody missed attending meetings—and that's probably what Grace is trying to do now
 - vi. Desmond: Officers who go above and beyond, can receive bonuses.
 - vii. Cindy: The reasons she missed the senate meetings were for personal reasons, juggling a lot of things this semester
