Step 2 - Were the "Dark Ages" Really That Terrible in Europe?

Peter S. Wells is a professor of archaeology at the University of Minnesota. He is one of the world's leaders in the archaeology of Europe. This is an excerpt from his book, Barbarians to Angels: The Dark Ages Reconsidered (2008). In his writing, he argues that the "Dark Ages" of medieval Europe were not as terrible as originally believed. As you read the excerpt, highlight the evidence Wells uses to support this argument.

...Of fundamental importance was the development of a new technology of agriculture - the moldboard plow - which vastly increased the efficiency of food production beyond anything in Roman times. This new technology meant that fewer people could produce larger harvests than was possible earlier, thereby releasing many former farmers to work in other, specialized, activities such as manufacturing, trade, and building.

During the "Dark Ages," innovations in architecture led to the emergence of the familiar cathedral of the High Middle Ages. An architectural historian has written recently that during the period of 565-800, "medieval architecture was born."

Crafts workers created a new style of art during this period. It was expressed on personal ornaments such as gold brooches and intricate belt decorations, in exquisite chalices for churches all over Europe, in the illuminated manuscripts of Celtic Britain and Ireland, and in the decorations on ship prows and church facades throughout the continent.

If formal education faltered in Italy and some other former lands of the Empire, it thrived elsewhere, especially in Ireland. During the sixth century, Columba founded his internationally famous center of learning at Iona. Columbanus, educated in Ireland, left to establish monasteries and schools on the continent, bringing with him a whole tradition of learning.

With the breakdown of Roman political organization in the provinces, Roman law ceased to be enforced. But each new national community created its own code of laws, partly based on the Roman system but always with distinctive features that grew out of their own traditions. Frankish, Irish, and Anglo-Saxon law codes were written down in the course of the sixth century.

Most importantly, all of these developments grew out of the local traditions of the people of temperate Europe, including the Franks, Anglo-Saxons, and Goths. The experience of Roman rule had an effect, but the new civilization that emerged with Charlemagne was distinctly European, not Mediterranean.
