Meeting Overview

The Advisory Council Meeting held on October 25, 2024, featured a range of stakeholders discussing key issues and achievements within the Colorado community corrections landscape.

Vice Chair Erick Javaneau facilitated the in-person meeting, with attendees from various corrections and justice organizations contributing insights.

Presentations covered topics such as the Colorado Community Corrections Coalition's person-centered approach, Core Civic's evidence-based practices, and GEO Group's programming services, all addressing challenges like inflation, unutilized capacity, and workforce development.

A significant portion of the meeting was dedicated to updating the council on recidivism tracking methods, highlighting the need for aligned treatment approaches.

Future planning included skipping the December meeting, encouraging goals from council members, and inviting individuals with lived experience to participate in upcoming sessions. Action items were outlined for presenters and members to ensure continued progress and stakeholder engagement.

- Presented achievements: implementing evidence-based practices, technology advancements, normalization efforts, highlighted success in combating opioid epidemic in facilities
- Challenges: referral process, unutilized capacity, staff recruitment and retention
- Highlighted success in combating opioid epidemic in facilities

GEO Group Presentation

- Jeaneene Miller and Angie Phebus presented on behalf of GEO
- Discussed accomplishments: programming services, partnerships, peer support
- Challenges: referral process, unutilized capacity, parole officer involvement
- Suggested areas for improvement: board education, policy development

CACCB Presentation

- Steve Reynolds presented on behalf of CACCB
- Discussed rebuilding relationships with stakeholders, improving acceptance rates
- Emphasized need for education on evidence-based practices and community engagement

Recidivism Update

- Discussed new recidivism definition and tracking methods
- Highlighted limitations and challenges in comparing recidivism across different parts of the system
- Discussed need for appropriate treatment approaches aligned with recidivism definitions

Future Meeting Planning

- Discussed potential agenda items for future meetings
- Agreed to skip December meeting and reconvene in January
- Suggested inviting individuals with lived experience to future meetings
- Discussed setting SMART goals based on stakeholder input
