We can't believe it's getting to be that time again! The 2013 pool season is only a few months away! Enclosed is your pool pass application for 2013. At the top right hand side of your application, please check the appropriate box based on the description below:

[] **New Member** – Anyone new to Cub Run who has not recently received pool passes

[] **Renewal – With Changes** – Anyone who has received pool passes, but has changes from prior years. **PLEASE INDICATE THE CHANGES ON THE APPLICATION. FAILURE TO DO SO WILL DELAY THE PROCESS.**

[] **Renewal – No Changes** – If you just need stickers

Please note that there is a \$15.00 charge per pass for replacement pool passes.

As a reminder, anyone wanting to pick up new pool passes will need to come to the registration dates as shown below. You may also have new passes sent to you by mail. Unless otherwise noted, the open registration will be held at the office of Sequoia Management.
