- I. Opening prayer (2 min) Dalton opened the meeting in prayer at 12:15 pm
- II. Approval of February meeting minutes (2 min) Rick motioned to approve the February meeting minutes and Ruth seconded. The Council unanimously approved the minutes.
- III. Avondale Pattillo Josh / Laura (10 min) Rick motioned to move into Executive Session and John Bartholomew seconded. The Council voted unanimously to move into Executive session.
- IV. Solar and DFUMC long-range church priorities Josh (30 min)

 Josh led a discussion concerning the solar panels. The council began by

 discussing the recent congregation meeting about the panels and the concerns

 raised by congregation members. Specifically, the Council discussed

 congregation members' concerns about future projects being delayed,

 including renovating the sanctuary and proposals by congregation members

 to renovate the kitchen. The council further discussed communicating to the

 congregation about its deliberative and decision-making process, including

 the long process the solar panel task force undertook. Council members

 agreed they needed to send a communication to the congregation about

 delaying a vote.
- V. Financial Report Tom (10 min)
 Tom gave a financial report. The church continues to maintain a strong cash position of over \$175k. Discussing our monthly financials, Tom noted that \$2000 is being transferred into a reserve account for maintenance and

repairs. The preschool remains profitable, and Avondale Pattillo is currently breakeven. The Church has submitted its ERC application which would net up to \$300,000, and our Reviewed Financial Statement for 2022 is completed. The endowment committee met 2 weeks ago. John Robinson, an attorney, is now joining that committee. The Church has completed its 4% withdrawal from the endowment for the year. Tom moved to approve the financials and Ruth seconded. The Council unanimously approved them.

VI. Holy Week - Dalton (2 min)

Dalton gave an update on holy week plans, including times for service throughout the week, and when catered meals will be provided for services.

VII. SPR - Marion (20 min)

Multiple members moved and Rick seconded to move into Executive Session to discuss SPR matters.
