- McGrath North HOA Seminar Patti attended this seminar and brought to our attention that a law that was put into effect in 2020 for CTR – Corporate Transparency Act has a 12/31/24 deadline for filing FinCEN, and may apply to our HOA, Tony and Shane are looking into this
