Inside The Life of Philip Unisky

Philip Unisky is the executive director and was the founder of the Youth Policy Institute. The Youth Policy Institute is a Non-for-profit agency created to provide service for vulnerable children and their families. By creating this institute Unisky has become a legislative counsel and legal advocate for families and youth at risk (youth policy institute.org). Mr. Unisky has worked his entire adult life and career dedicated to serving children and youth. I desire to be like Philip in my future career, because of what he stands for. He stands for helping the youth and their families that are in desperate need of help, and he was able to create an entire non-profit organization dedicated to this cause. I hope to be like Philip, or anywhere near as successful as he has been, in helping the youth with their lives.

Mr. Unisky established the Youth Policy Institute in late 1996. (youth policy institute.org). Prior to establishing the institute, Philip served as Codes Counsel to the New York State Assembly and was the principal negotiator of several consequential notions. He was a key participant in the passing of the New York State's Family Protection and Domestic Violence Intervention Act that was passed in 1994. He also was heavily involved in many activities that were created to improve the legal representation of youth in special education as well as delinquency. Along with being the director of the Youth Policy institute, he was the director of the Partnership for Results from the year 1999 to 2008 (linkedin.com). This incorporation greatly improved researched-based mental health, education levels, family therapy services, reduced levels of violence, delinquency, and youth criminality. From the year 1994 till 1996 Philip was also a part of the program Statewide Youth Advocacy.

Philip also served as a social scientist to Bowdoin College, Hamilton College, and the world-renowned Harvard University. Prior to all of Mr. Uniski's success, he received his bachelor's degree at the University of Michigan. Also, he attended the New York University School of Law from the year 1989 till 1992 where he graduated with a degree in Law. (linkedin.com)
