We recommend that the Community Reparation Commission (CRC) form an independent, Reparations Accountability Council (RAC) which would oversee all CRC recommendations implemented by the city and county and their contractors. The purpose is to articulate the intent of structural and systemic recommendations, ensure fidelity in the implementation of the CRC recommendations, monitor the progress and effect of CRC recommendations, and ensure city/county compliance with the Reparations resolution that each adopted. The CRC will empower the RAC to serve as its voice at Asheville City Council and Buncombe County Commission meetings The RAC shall implement continuous accountability measures and monitor city/county progress on CRC recommendations across all commission impact focus areas The RAC shall have input and oversight responsibilities on initiatives, construction, spending, etc that impact Black residents and Black communities in Asheville and Buncombe County The RAC shall be charged with developing and implementing a review process for identifying continuing harms and harms that may occur due to future policies and actions. The RAC shall be empowered to advocate for ongoing assessment of harm mitigation The RAC shall be charged with monitoring and assessing the

organizations who may partner with city/count to implement CRC recommendations

- The RAC shall be charged with monitoring the city and county's efforts to procure funding from Federal, State, and Local sources that can support economic development in the Black community
- The RAC shall ensure that all resources secured for Reparations are used to accomplish the goals of the Reparations Commission

Parameters

- The Reparations Accountability Council will consist of the following personnel:
 - (5 people) one person to represent each IFA
 - o (1 person) executive director
 - (1) attorney
- The RAC will work closely with existing community groups to monitor implementation progress and impact of commission recommendations
- The RAC or its designee will have a seat on city/county boards and commissions whose charter influences the quality of life and development of Black communities throughout the city and county to ensure Black representation in the decision/policy making process

Notes:

- Each IFA will have to develop a specific accountability structure for their area based on approved recommendations
- Each IFA recommendation has to have an assessment mechanism that can be monitored to assess improvement/compliance
