

Privacy Policy

This Privacy Policy governs how we collect, use, share, store, and otherwise process your information when you use Diva Onet: Magical Connect. Please read this Privacy Policy carefully.

01 - Age requirements

02 - Use of Information

We may use your information to:

- (1) provide, maintain, and improve our Service, including to monitor the usage of our Service.
- (2) contact you by email, or other equivalent forms of electronic communication.
- (3) attend and manage your requests to us.

03 - Collection of Information

You provide us with your personal information directly. Such as your email address;

We may receive usage information from applications running on your device. Such as: device identifiers (such as GAID), device information (such as device type, brand, operating system, language, resolution), usage logs;

Where permitted by law, we may also obtain information from public and commercial third-party sources.

04 - Sharing of Information

We may transfer or disclose the personal information we collect (after anonymization) to providers who provide services to us, which may include providers of IT services, data analysis, data backup and archiving, security and storage services (including cloud service providers). These service providers and we will process your information strictly in accordance with the privacy rules of Apple Inc.

05 - Retention of Information

We will retain your information for as long as needed to provide and develop the App. We will also retain and use your information as necessary to comply with our legal obligations, resolve disputes, and enforce the Terms of Service. We may retain information that no longer identifies you indefinitely.

06 - Protection of Information

In order to protect your personal information collected by us and third parties we work with, we use industry-standard physical, procedural and electronic security measures, including encryption where deemed appropriate.

07 - Your Rights

You have the right to:

- (1) obtain your information in a structured, machine-readable format.
- (2) request to update, amend, correct, or rectify your information.
- (3) request that your information be deleted. However, we will deny you this right if we have reasonable grounds for doing so.
- (4) withdraw your consent at any time. The withdrawal of consent does not affect the lawfulness of processing based on consent before its withdrawal.
