**Tuition Discounts Available** - Active Military, First Responders, & Pastoral - 15% off of tuition per child. Annual Application required.

**Tuition Aid** – The purpose of tuition aid is to make an education at DRA available to more families by providing a reduced rate based on each family's personal financial situation and allocated funds available. **Enrollment fees** will be processed through the payment processing system. \*Families re-enrolling 3 or more students will have a total \$300 re-enrollment fee. **Enrollment fees are non-refundable and non-transferable.**

**The Curriculum and Materials** fee is due July 1 (or at time of enrollment if enrolling after July 1, 2025) and will be processed through the payment processing system. The Curriculum and Materials fee is **non-refundable and non-transferable.**

**Financial Policies  
and Procedures**

1. This **Schedule of Tuition/Fees and Financial Policies and Procedures** statement is an addendum to the legally binding student enrollment contract.
2. **Records Review, Admissions Evaluation, and Processing Charge:** Following initial contact with DRA, the parent/guardian of the student(s) must submit a complete file of the student's records for review by the admissions office. In addition, a placement evaluation is required for all candidates for admission. The student records, placement evaluation, and other items deemed necessary for enrollment consideration will be reviewed by the admissions committee for a recommendation to the parents regarding admission to DRA.
3. **Registration:** A student may be admitted to DRA only if the parent/guardian agrees to enroll the student for the full school year or for that part of the year remaining after admission and to pay tuition and fees for that period. A student is considered enrolled at DRA at the time the parent/guardian signs the enrollment contract for the enrollment period and pays a non-refundable registration fee. If a student is withdrawn by the parent/guardian from DRA at any time and for any reason after registration, the registration fee and curriculum and materials fee will not be reimbursed.
4. **School-Year Admission:** When a student is fully enrolled prior to the opening of the school year or at any time during the month of September, the published tuition rate applies. When a student enrolls on or after October 1, tuition will be prorated from the date of admission. A student may not attend classes until enrollment, curriculum, and materials fees, and the applicable tuition have been paid in advance.
5. **Payment Plan:** All DRA families must enroll in the payment processing system with a designated payment method for billing and any other additional fees.
6. **Late Fees:** A \$35 late fee and/or a \$30 insufficient funds fee will be applied to any account that lacks sufficient funds for the initial payment withdrawal via the payment processing system. Once the bank notifies the school of an unsuccessful payment, the primary account holder will be notified and given 5 business days to resolve the issue. If payment is not received within 5 business days, the student(s) will be considered conditionally withdrawn and will not be allowed to attend classes until the balance is paid in full. If the account is referred to a collections agency due to non-payment, the parent(s) or legal guardian(s) agree to be responsible for all associated costs, including but not limited to collection agency fees, attorney fees, and any other reasonable expenses incurred in collecting the outstanding balance.
7. **Added Services:** There are programs that require an additional application and acceptance that have fees associated with them, separate from the DRA registration, enrollment, curriculum, materials fee, and tuition fees. If a student is involved in these programs (as noted on the reverse side), additional fees and/or registration forms must be completed and are in addition to the DRA enrollment charges.
8. **Tuition Assistance:** Financial awards are need-based, using an online application process which includes the submission of current year tax documents. In addition, families are required to submit a signed enrollment contract, records review, admissions evaluation, processing fee, and registration fee before an official award notification is given. However, we understand that sometimes, even with financial assistance, families may still not be able to afford the cost of DRA. Therefore, DRA will allow families seven (7) days from the award notification to review the award before declaring (in writing) their intent to accept or decline the award and enrollment.
9. **Student Exit Policy:** Students are considered enrolled for the entire year; therefore, budgets and teacher contracts are set accordingly. In the case where a student withdraws before the last day of the school year, the following policy applies: (a) A parent/guardian must provide in writing to the school administration the intention to withdraw the student(s) from DRA and complete the Student Withdrawal form. (b) The obligation to pay tuition for the full academic year is made at the time of enrollment and is unconditional. ***Numbers 30:2 states that when a man makes a vow to the Lord or swears an oath to bind himself, he must not break his word but must do according to all that proceeds out of his mouth.*** (c) Exclusions: A prorated tuition refund may be considered in the event of job relocation, military reassignment, financial hardship resulting from a death in the family, or other circumstances deemed appropriate by the administration. Communication with the administration about financial accounts is vital for continued partnership.
