1. Purpose

Your booking is for a private leisure charter operated by Imperial Yachting. We provide fully crewed yachts for safe, comfortable, and premium cruising experiences in the UAE.

2. Booking and Payment

Total charter price is 12 000 AED.

- **Deposit:** 20% non-refundable deposit is required to confirm your booking.
- **Balance:** The remaining 80% is due on or before boarding.

- **Port or Marina Fees:** If you request special docking or extra stops, related fees will be added.

Date Changes:

- You may reschedule your charter **up to 48 hours before departure**.
- A **25% admin fee** applies for each date change.

Cancellations:

- **Less than 48 hours before charter:** full amount (including extras) is non-refundable.
 - **More than 48 hours before charter:** deposit is non-refundable, rest is refunded.
 - If weather or safety restrictions apply, we may offer a new date or booking credit.
 - If Imperial Yachting must reschedule due to our own operational reasons, we will offer a new date, a full refund of your booking (including any deposit), or provide an alternative yacht of similar or higher standard.

3. What's Included

- Private use of the yacht and its standard equipment
- Licensed professional crew
- Fuel for standard routes

You're welcome to bring your own food, drinks, or entertainment, or request extras like catering, décor, music, or private chefs — just let us know in advance to prepare smoothly.

4. Yacht Condition

Every yacht is delivered clean, fully operational, and safety-checked.

If any technical issue affects your trip, we'll arrange a suitable replacement or partial refund.

5. Guest Conduct & Safety

- The number of guests **must not exceed the yacht's legal capacity**.

- Please follow the **crew's instructions at all times** — this is for your safety.
- Illegal activities or reckless behavior are not allowed.
- Any damage caused by you or your guests will be charged at cost.

Imperial Yachting may **end the trip early without refund** if guest behavior risks safety or violates UAE law.

6. Photos, Videos & Privacy

We sometimes capture general photos or short videos of the yacht and scenery for marketing.

- We will **never post any content showing you or your guests** unless you give clear approval **by message**.
 - You're welcome to bring your own photographer or content creator — just **let us know by message** so we coordinate and ensure safety.
 - Imperial Yachting logos and signs must stay visible during the charter.
 - Client is permitted to capture photos and videos during the charter for their own use, including promotional purposes, without any limitations or requirement for Imperial Yachting's prior approval.

7. Liability & Insurance

Our yachts are fully insured under UAE maritime regulations. However, Imperial Yachting is **not responsible** for:

- Personal belongings lost or damaged on board
- Injury or accidents unless caused by gross negligence
- Schedule changes due to weather or safety reasons

We recommend that all guests have personal travel or health insurance.

8. Force Majeure

If we must cancel or delay the trip due to weather, technical, or government reasons, we will offer an alternative date or partial refund — whichever is most reasonable.

9. Governing Law

These terms are governed by the laws of the **United Arab Emirates**.
Any dispute shall be handled by the **Courts of Dubai**.

10. Agreement by Message

Once you confirm your booking and deposit **by message or payment**, these terms automatically apply.

That confirmation serves as your agreement to all points above.
