The Warren County Board of Supervisors posted the settlement agreement, so if you have any trouble accessing it, go to the county's

page https://madisoncounty.iowa.gov/offices/board-of-supervisors/ and the document is located under the "Ordinances" section.

As to question 3, our current plan, called Wind PRIME, has been filed with the Iowa Utilities Board and is subject to approval. Overall, MidAmerican plans to invest \$3.9 billion on Wind PRIME. As stated in the public portion of the documents we filed last month with the Iowa Utilities Board, our company projects that customers will receive the benefit of \$1.8 billion in tax credits, which would offset 45% of the cost of the project. We intend to add 2,042 MW of wind generation and 50 MW of solar generation. We have requested cost caps of \$1,890/kW for wind investment and \$1,854/kW for solar.

Regarding question 4, while we have obtained valid permits, we have not filed a project plan with the Iowa Utilities Board. Thus, that information has not been determined.

Thanks for contacting us about the Madison County wind ordinance matter and our settlement agreement with the county.

MidAmerican Energy has entered into voluntary agreements year-after-year with thousands of landowners since 2004, and that continues to this day. For nearly 20 years, MidAmerican has invested nearly \$14 billion to construct 37 wind projects and more than 3,300 turbines spread across 32 of lowa's counties. MidAmerican's wind farms are only possible because of landowner partners who sign voluntary easements and communities that welcome the positive economic impact they provide.

MidAmerican only brought a lawsuit in the Madison County ordinance matter to protect its legal rights for projects the county had already approved and in which the company had already invested, including an ongoing and operational project. MidAmerican did not attempt to disrupt the county's right to limit new developments, and in the course of the settlement was willing to reduce the total number of turbines it could construct out of respect for the county's concerns.

The company never aspired to collect damages from the county; again, our interest was in protecting our legal rights to the projects the county had already approved and the investments we had already made, based on those approvals. We worked hard during the settlement process with the county's attorneys to reach a result that avoided any damage payments by the county. Any assessment or projections of potential liability or damages provided to the county came from its own attorneys.

The settlement agreement, which you can view here, was negotiated with the county's legal counsel over the course of months and does not, nor ever did include, any special arrangements with Supervisor Fitch or any other individual supervisors. All siting considerations are made according to the usual criteria for siting wind projects.
