"NASP does not support assessment procedures known as risk assessment. Such procedures claim to identify or "profile" students as being "at risk" of committing acts of violence; research shows that such methods are associated with high false identification rates. While many students have emotional or behavior difficulties, relatively few commit serious violent acts and using so-called "violence risk profiling" assessments are more stigmatizing than useful. Instead, NASP believes that schools can and must respond to all threats that students (and others) make on school campuses. For this reason, NASP endorses using a threat assessment approach to understanding students' potential violent behavior (Cornell & Allen, 2011)"

Threat Assessment & School Safety-Related Legislation

<u>Threat Assessment, Prevention, and Safety (TAPS) Act.</u> H.R. 6664 (U.S. Congress) https://babin.house.gov/news/documentsingle.aspx?DocumentID=2135

This bill directs the Department of Homeland Security (DHS) to establish within itself a Joint Threat Assessment and Management Task Force, which shall provide recommendations to Congress and DHS on the development and implementation of a national strategy for preventing targeted violence through threat assessment and management. The task force shall make recommendations relating to the most effective use of existing government infrastructure, workforce, and experience, unit support, training, and school violence prevention.

EAGLES Act of 2018. S. 2759 (U.S. Senate)

This bill would expand the mission of the National Counter Terrorism Center to conduct research into targeted school violence; provide training in school violence prevention; and to coordinate and consult with other federal agencies and state/local agencies

STOP School Violence Act of 2018. H.R. 4909 (U.S. Congress) [Current Law]

The STOP School Violence Act reallocated grant monies from the Omnibus Crime Control and Safe Streets Act of 1968 away from school physical security enhancements and towards mental health programs, reporting systems, and behavioral threat assessment teams. This is current law.

Marjory Stoneman Douglas High School Public Safety Act. Florida [Current Law]

Passed in the wake of the Marjory Stoneman Douglas High School shooting, this bill mandates numerous school safety related measures including mandated threat assessment teams.

Claire Davis School Safety Act. Colorado [Current Law]

Passed after Claire Davis was murdered at Arapahoe High School when the school failed to properly follow through on conducting a thorough threat assessment on Claire's murderer. This act imposes a limited waiver of sovereign immunity for a school if a school fails to exercise "reasonable care" to protect all students, faculty and staff from "reasonably foreseeable" acts of violence that occurs at school or a school-sponsored event.

Threat Assessment in Virginia. Virginia [Current Law]

A previous law (2008) was based requiring all public institutions of higher learning in Virginia to have campus threat assessment teams.

<u>Critical Components of a Best-Practice K12 School Threat Assessment Program</u>

- 1) **Top-down mandate** (Superintendent and school board)
- 2) School Climate/Culture
- 3) Formal Policy/Procedures
 - a. Designate all threat assessment team members as "school officials with a legitimate educational interest."
 - b. Team membership
 - c. Training
 - d. Reporting mechanisms
 - e. Follow-up procedures and mechanisms
 - f. Recordkeeping
- 4) Education on warning behaviors for staff, students, and parents
- 5) Reporting system (anonymous)
- 6) Training for members
 - a. Initial formal training
 - b. Periodic update and refresher training
- 7) Multi-disciplinary, must include (at minimum):
 - a. School administration
 - b. Counseling or mental health
 - c. Law enforcement
- 8) Referral/Caretaking Resources
 - a. Internal school district programs
 - b. External programs
