- Rui Figueira (GBIF Portugal) highlighted some issues with the GBIF Portugal installation that we have now fixed after the workshop
- The ALA team are working to the roadmap here:

- Documentation It was recognised that the ALA images service component needs some documentation here: https://github.com/AtlasOfLivingAustralia/documentation/wiki The documentation would cover installation and basic usage.
- A page on the <u>gbif.org</u> with information around ALA and its implementation by other countries is needed
- Rui mentioned the importance of developing an ALA portal covering a big area such as the Peninsula Iberica (no biodiversity border) useful to make different scientific studies
- As the GBIF Implementation Plan states the Secretariat will already allocate one person for ALA tasks (not full time). But:
 we need a full time person, with technical background but also someone who needs to have competences in management, answering calls for projects, etc.(Not Tim Robertson who already has a lot of work)
- After the workshop and the CoopBioPlat meeting in Madrid it was clear that more support from the GBIF Secretariat in this task is needed. So, members of GBIF France, GBIF Portugal and GBIF Spain prepared the text here (changes highlighted in orange) to be add it in the GBIF Implementation Plan 2017-2021. 16 GBIF participants endorsed this proposal that would be discussed in the next GB23 in Brazil.
