#1 – APPROVAL OF QUALITY COMMUNITIES PROGRAM GRANT APPLICATION – HN-05-15

(Resolution authorizing the filing of an application for a Quality Communities Program Grant for the creation of a Hakes Avenue Redevelopment Plan and signing of the associated state contract, under the appropriate laws of New York State.)

WHEREAS, the State of New York provides financial aid for innovative community planning and development of implementation tools and strategies that link environmental protection, economic prosperity and community well-being; and

WHEREAS, the City of Hornell, herein called the MUNICIPALITY, has examined and duly considered the applicable laws of the State of New York and the MUNICIPALITY deems it to be in the public interest and benefit to file an application under these laws; and

- 2. That Shawn D. Hogan is directed and authorized as the official representative of the MUNICIPALITY to act in connection with the application and to provide such additional information as may be required and to sign the resulting contract if said application is approved by the STATE.
- 3. That the MUNICIPALITY agrees that it will fund its portion of the cost of said Hakes Avenue Redevelopment Plan.
- 4. That this resolution shall take effect immediately.

NEW & UNFINISHED BUSINESS:

- Mayor Hogan noted the Common Council's Finance Committee would review the proposed 2005-06 City Budget at 5 p.m. Wednesday, March 02, 2005, in the Mayor's Conference Room at City Hall. A public hearing on the budget will be held at 9 a.m. Saturday, March 5, 2005, in Council Chambers at City Hall.
- Mayor Hogan reported extensively on his NYCOM Winter Legislative Session trip to Albany, and distributed material to the Common Council that showed how pension bills have skyrocketed for Hornell and other New York cities in the past two years. In Hornell's case, pension contributions have risen \$683,300, or 28 percent, in two years. Forty-three percent of New York's cities, including Hornell, were forced to either borrow or amortize to pay for their contributions to the pension system. Mayor Hogan said he borrowed so as to not unnecessarily burden City taxpayers in case there were developments in Albany to relieve the pension burden. "The impact on communities is devastating, absolutely devastating," Mayor Hogan told the Council, adding that the City may have to borrow \$148,000 more to pay for police/fire pension contributions next year. "Almost 10 percent of our budget is going to cover pension costs. Something is out of whack," the mayor said. Gov. Pataki has proposed a revenue-sharing plan that could provide an extra \$362,000 to the City of Hornell over the next two years, if overall City spending does not rise more than 3.5 percent (whether this will include pension contributions, which are beyond City control, remains to be seen). Mayor Hogan said he was proud of the City of Hornell's fiscal restraint in being well below the state average for tax increases. Alderman Norton, who accompanied Mayor Hogan to the NYCOM session, said he wanted residents to understand the City is not targeting retirees; Mayor Hogan agreed, saying pensioners will get what state constitutional law entitles them to.
